Our agency is conducting an ongoing criminal investigation that involves the Facebook.com user name of Jake Roberts. As part of that investigation and pursuant to 18 U.S.C. § 2703(f), we are requesting specifically that the account/profile be preserved pending the issuance of a search warrant or other legal process seeking disclosure of such information: all page content, photographs, videos, bulletins, text, links and other information and data that would be available to any person with access to their page. I understand that Facebook.com will lock the profile/account in question, thereby rendering the account inaccessible to its owner. I also understand that certain data associated with the account such as sent messages are subject to automatic deletion.



## NARRATIVE:

On 12-12-12 at approximately 10:00am, I was given the assignment to contact three businesses, Wal-Mart, 10000 SE 82<sup>nd</sup> Ave, Happy Valley OR, The Gun Broker 14981 SE 82<sup>nd</sup> Dr, Clackamas OR and Wholesale Sports 9401 SE 82<sup>nd</sup> Ave, Portland OR in order to get information about transactions Jacob Roberts made at those businesses prior to 12-11-12. Found during a search warrant on Jacob Roberts' residence on 12-12-12 were several receipts for the purchase of ammunition, magazines and other items possibly related to the shooting at the Clackamas Town Center on 12-11-12 at those businesses. On 12-13-12 at approximately 2:00pm, I went to the Wal-Mart department store, 10000 SE 82<sup>nd</sup> Ave, and contacted Victor Murguia, Loss prevention officer. I showed Mr. Murguia the three receipts from Wal-Mart and asked that he find the video of Jacob Roberts. I showed Mr. Murguia a picture of Jacob Roberts and Mr. Murguia was able to show me that on two days, December 8<sup>th</sup> and December 9<sup>th</sup> the video for both days showed Roberts driving into the parking lot and then coming into Wal-mart alone and purchased ammunition, targets and earplugs. The video showed Roberts leaving the store alone and driving out of the parking lot. It did not appear that anyone was with Mr. Roberts when the purchases were made.

I requested a copy of the video and Mr. Murguia said he would get the video together and have it ready on Monday 12-17-12.

On 12-17-12 at approximately 10:00pm, I went to Wal-Mart and met with Mr. Murguia. Mr. Murguia gave me two CD's, one for each day and a corresponding narrative of Roberts actions/movements while on Wal-Mart's property. See Attached for the narrative. I made a copy of the items given to me by Mr. Murguia and entered the items into property as evidence.

Joann explained one of the girls went to a separate room to play pool with two guys. Jeff is a large man, 6'6" tall and went into the pool room to check on the female and make sure the two guys were okay. Joann said the two guys seemed okay to Jeff and he reached out to shake their hands. The first guy had a beanie and shook his hand then the second guy shook his hand. Jeff's group then went to watch the girl and two guys play pool.

Joann said she asked Jeff what the guy with the beanie's demeanor was and his answer was they were joking and laughing. Joann asked what the energy of the guy with the beanie was. Per Jeff, his hand shake was of total relaxation, to the point of numbness and Zen. Jeff referred to him as a Zen master.


Joann said where she is going with this is when her son went back to Putters on the 17<sup>th</sup>, the bartender came running up to her son. The bartender told him the guy he shook hands with was Jacob, the Clackamas shooter. Per the bartender, Jacob went to Putters often as he worked at the nearby Gyro store.

On 12-11-2012 at about 1700 hours I was asked to assist with the interview of witnesses at the Tri-Met garage near the town center. As witnesses were brought to the garage by patrol they were passed off to Investigators to conduct interviews.

I first made contact with Ms. Cremeen and Ms. Tucker. I spoke with them at the same time as Ms. Cremeen had physical disabilities and Ms. Tucker was assisting with her care.

Ms. Cremeen told me she was in front of Zumiez and had stopped there to take a break as she had felt a seizure coming on. Ms. Cremeen told me she was leaning up on the rail when she heard a "pop" like an M-80, quickly followed by 4 more.

Ms. Cremeen said someone yelled to get down so she did. Ms. Cremeen said she looked across and saw a person dressed all in black, with a white mask, a vest, and holding a black rifle that he was waving around in the air.

Ms. Cremeen said she could see the subject had gloves on but she could see his wrists and saw he was light skinned. Ms. Cremeen told me she did not hear the subject say anything.

Ms. Cremeen said the subject starting moving toward them and her boyfriend grabbed her and pulled her into the back of Zumiez. Ms. Cremeen said she stayed in Zumiez until she was escorted out by the Police.

Amanda Tucker told me she heard gunfire and saw everyone running and she ran into Zumiez and when she looked back saw Ms. Cremeen being drug into Zumiez by her boyfriend. Ms. Tucker told me she hid in the store until escorted out by the Police.

I thanked Ms. Tucker and Ms. Cremeen for giving a statement. I escorted them outside.

I then spoke with Vicki Napoli.

Ms. Napoli told me she had been in the second level of Macy's and was walking from Jewelry to scarves. Ms. Napoli said she saw a man that "ran faster than anyone she had ever seen" run past her. Ms. Napoli said the man was running from outside the store to the main mall. Ms. Napoli also told me the man had on a "Scary hockey mask" and was carrying a black rifle. Ms. Napoli said the man didn't say anything and looked like he was a man on a mission.

Ms. Napoli told me she told the employee that it was not funny. She said the employee told her it was a joke and it was a plastic gun.

Ms. Napoli said a few seconds later shots began to ring out. She said she heard someone yell about a gun. Ms Napoli told me she turned and ran out of the store and ran outside. Ms. Napoli said many people ran outside and after she turned and ran she never saw the suspect again but heard a few more shots while she was running.





## **NARRATIVE:**

On 12-20-12 at about 1:15 PM, Detective Ashby and I spoke with Leah Reed at her home in Gresham, Oregon. It was my understanding that Ms. Reed was a very close friend of Jacob and he considered her his "sister."

Ms. Reed invited us into her home and we spoke for about 45 minutes. Ms. Reed said she and Jake have been very close since their time together at Milwaukie High School. She said she met Jake when she was a Junior and he was a Sophomore. Ms. Reed said their close friendship began almost instantly and she considered him like a brother.

Ms. Reed said Jake spent this last Thanksgiving with her and her family and that he had a stocking for Christmas at her mother's house. Ms. Reed told me Jake would sometimes act a little subdued during the holiday season because, in Ms. Reed's opinion, he was sad his mother and father were not a part of his life.

Ms. Reed said that for the vast majority of the time she knew Jake he was a very happy and fun person to be around. She described him as being loving, caring, funny and someone who was always there when you needed him.

I asked Ms. Reed about Jake's breakup with Hannah because she had said Jake was really in love with her. She said she thought Hannah was cheating on Jake and Jake took the breakup hard at first but had gotten over it.

Ms. Reed told me she learned about Jake's moving to Hawaii over Facebook pretty recently. It was Jake's plan to move in with an unknown friend who already lives in Hawaii. She said she last saw Jake at the Space Room on Friday December 7<sup>th</sup> and he bought her a shot of alcohol and they celebrated his trip to Hawaii which was supposed to happen the following day. She described his mood as happy and funny, which was normal. Ms. Reed said she received a text message in the days after that from Jake saying he had missed his flight but was still going.

Ms. Reed was certain of Jake's trip to Hawaii because when they spoke on December 4<sup>th</sup>, Jake told her he had sold his car and his couches had been put up for sale on Craigslist.

Ms. Reed said Jake did not have any mental health history that she knew about and she said he did not take any medication. She said he smoked marijuana almost daily and she thought he drank alcohol daily as well. Ms. Reed thought Jake might be an alcoholic because of his constant alcohol use.

Ms. Reed said Jake owned a 9mm pistol and he would shoot it every now and then outside of Estacada but he was not obsessed with it. Ms. Reed said he liked to take it apart and put it back together in front of her, which she thought was weird but he never talked about hurting anyone.

Ms. Reed had heard that most of the rounds hit the ceiling of the mall and suggested Jake was going there to be shot and killed by police, though he never had been suicidal in the past. Ms. Reed suggested that when Jake accidentally killed people at the mall he then committed suicide.




On 12-13-12 at about 12:15 PM, I decided to view the evidence that was seized from the search warrant at the suspect's address, [REDACTED] Ave, Portland, Oregon. Detective Burlew told me the evidence was located in the bottom floor of the CCSO Brooks Building in an evidence locker. He gave me the locker key and I retrieved all of the individually bagged property from the locker.

I took the items of property to the Detectives storage room #385 and layed out a large sheet of butcher paper on the table and then placed the bagged items of evidence on top of the butcher paper. I donned latex gloves and went through most of the items of evidence, taking pictures as I looked through the items. After I was finished with each item I placed them back in the bag they came from and resealed the bag.

When I was finished looking at all the evidence I took it back downstairs and locked it in an evidence locker for CCSO Property Room staff to pick up at their normal pickup date and time.

I later placed the images from my property viewing onto a photo CD and put that photo CD into evidence.

This is a package of "shoot n see" targets that had not been opened



**NARRATIVE:**

On 12-18-12 at about 10:04 AM, Detective Cate and I spoke with Brittany Curry at her home in SE Portland. It was my understanding that Brittany is a recent ex-girlfriend of Jacob Roberts.



Brittany told me she met Jake in May of 2011 and they hung out as "friends" for several months before they started dating. She said that during their friendship they would often shoot guns outside of Estacada together though it was not an "obsession" for him. Brittany said Jake owned a 9MM pistol that he purchased at an unknown gun shop on SE Foster Road. Jake was very aware of firearms safety and never pointed his pistol at anyone else either on purpose or by mistake. Brittany said Jake also liked to play "beer pong" and go hiking.

I asked Brittany about Jake's alcohol and drug use. She said he smoked marijuana almost daily for a period of time during their relationship but then quit. She said he drank casually and said it was not a "problem" for him. Brittany said Jake did not take any prescription medication or street drugs, other than marijuana, during their relationship.

Brittany told me her relationship with Jake ended in March of 2012 when Jake started dating other girls.

Brittany said Jake did not have any mental health history that she knew about and described him as a "happy" person who always put others before himself. Brittany was aware that Jake's mother died when he was young and Jake was raised by his Aunt until they had a falling out in his teens.

According to Brittany, Jake never got into any fights and was a very peaceful person. She said he hated movies based on the military because he was upset he was not able to join the Marine Corps because of a foot injury.

Brittany said when they watch TV together the shows were mostly light hearted and comedic in nature. She said he did like to watch horror movies but not very often. When I asked Brittany about Jake's video game playing she said he rarely played them and when he did they were mostly racecar games.


Brittany told me she is shocked that Jake committed these acts and she cannot think of why he would do them.



Narrative:

On 12-12-12 at about 1234 hours Detective Nunn and I met with Mr. Gattuccio in an interview room of the CCSO investigations section. Mr. Gattuccio had self identified as a close friend of Mr. Roberts and had come to the Sheriff's Office of his own accord.

The interview was recorded and Mr. Gattuccio was advised of the recording.

I asked Mr. Gattuccio the questions for the personal history questionnaire about himself. He spoke for some time about Mr. Roberts. He said that Mr. Roberts was always kind hearted and was not violent.

They had last talked about one month ago. At that time Mr. Roberts told Mr. Gattuccio that the gyros shop where he worked was going under and the new owners would be laying off the current employees. Mr. Roberts invited Mr. Gattuccio to join him for a gyros lunch.

Mr. Gattuccio said that he had never heard Mr. Roberts talk about hurting anyone. Mr. Roberts had lived with Mr. Roberts' father until his father had kicked him out. Mr. Gattuccio seemed sad that Mr. Roberts had not felt like he had someone to whom he could turn.

Mr. Gattuccio said that he had introduced his cousin, Bonnie, to Mr. Roberts and they had dated. He eventually described to us that Mr. Roberts had infected Bonnie with chlamydia and impregnated Bonnie. He described some tension over Mr. Roberts being responsible for the cost of this situation.

Mr. Gattuccio said that Mr. Roberts even had difficulty with going hunting and had always said that people should "live and let live." He said that Mr. Roberts loved life.

Detective Nunn and I asked him questions from the FBI BAU General Assessment Questionnaire. See attached.

**NARRATIVE:**

On 12-12-2012 I viewed the autopsy of victim, Steven Forsyth, at the Oregon Medical Examiner's Office. The medical examiner was Dr. Christopher Young. Criminalist Andy Shelley was present in the autopsy room for photos and evidence collection. I monitored the autopsy from the viewing room. The following is a summary of information I gleaned from the viewing, and not a verbatim account. 



On 12-12-2012 I viewed the autopsy for victim, Cindy Yuille, at the Oregon Medical Examiner's Office. The medical examiner was Dr. Clifford Young. Criminalist Andy Shelley was present in the autopsy room for photos and evidence collection. I monitored the autopsy from the viewing room. The following is a summary of information I gleaned from the viewing, and not a verbatim report. For a complete report, refer to the Medical Examiner's report, which will be available at a later date.

The deceased was wearing a black zippered rain coat, and a gray v-neck sweatshirt, both of which were partially blood soaked. She had on dark blue jeans, a black bra, and light colored panties. There were two notes in the front jacket pocket, which were apparently Christmas shopping lists.

The apparent cause of death was from a gun shot wound. The entrance wound to the deceased's back was approximately 47 and a half inches above the base of the left heel, 5 and a half inches left of the midline. It was circular, about 3/16 inches in diameter.

The exit wound was in the mid sternum, centered about 47 inches above the base of the right heel. It was about 1 and a half inches by 1 inch, oval in shape. The bullet fractured the in the area of the eighth rib. It also perforated the lung, heart and sternum.

## NARRATIVE:

On 12-11-2012 at about 1534 hours I arrived at Clackamas Town Center, 12000 SE 82<sup>nd</sup> Ave. on the reports of a gunman inside actively shooting people. I teamed up with Sgt. Christensen,

Deputy Gibson, and Detective Millett, and we entered at the number 3 maintenance access hallway.

As we began our search I heard radio traffic say the suspect who was described as being armed with an assault rifle and wearing black with a hockey mask had just entered the Macy's home store near maintenance hallway #3 near the Macy's Home Store.

I opened the door to the main mall upper floor and I saw near the entrance to Macy's Home Store what I recognized to be a detachable rifle magazine lying on the ground. I heard or saw no indicators of the suspect's location.

I could see many people running out of the mall and could smell smoke and something burning.

My cell moved through the Macy's store and we did not encounter anyone except a Macy's security employee. Upon completion of the search of Macy's I took a custodial flag and placed it over the magazine to mark it's location and so people would not kick it when running out of the mall.

While searching I heard other cells broadcast they had located victims near the food court.

I then moved downstairs with my cell and we evacuated the store Forever 21. I located both employees and customers that had been hiding in locked offices or changing rooms. I asked if any of them had seen anything and I was told they had not seen anything and had only heard shots and had sheltered in place.

I escorted them out of the mall.

I heard another cell broadcast they had located the suspect deceased in the maintenance hall behind Gentle Dental.

I noted the emergency exit alarms were sounding in forever 21 and the emergency exit led to a maintenance hallway that ran behind gentle dental and toward JC Penney.

I made contact at Gentle Dental and noted there were many people inside. Gentle Dental employees had compiled a list of names and phone numbers of everyone that had been inside or had run inside the business. Nobody had heard or saw anything except Sandra Mix. I interviewed her and my interview with her is included in another report. Gentle Dental had written down the names and phone numbers of all the employees, customers, and people that had ran inside for safe haven. I have attached the list with my report.

I assisted with evacuating everyone from Gentle Dental.

As SWAT teams moved into the mall for a slower and more thorough search I cleared and returned to the command post to receive an assignment.

**Narrative:**

12/11/2012 at about 1615 hours, I was alerted via text message to a shooting which had just taken place at the Clackamas Town Center. I went enroute shortly after. While enroute I was called by Criminalist Finn who told me to meet her at the mobile command post which had been set up outside the Clackamas Tri-Met office.

I arrived on scene at 1656 hours and met with Criminalist Finn near the command post. I observed dozens of other law enforcement officers from varying agencies in the area.

Over the next hour, Criminalists from Clackamas County, Portland Police Bureau, Gresham Police, Canby Police and the Oregon State Crime Lab made a plan to divide into three teams to process the two deceased victims and one deceased suspect; who were all still inside of the mall.

I was given the assignment to digitally video record the scene and the one male victim who was reportedly located just outside the Macy's store. This victim was later identified as Steven Forsyth.

At 1834 hours, I entered the mall through the North entrance near the theatre and into the food court area. The other teams of Criminalists entered at about the same time. Criminalist Finn accompanied me looking for evidence and taking notes as I operated the video recorder.

As I walked through the food court area I observed a bullet hole in the top center of an advertisement kiosk which was in the approximate center of the food court. The glass on the front of the kiosk (facing southeasterly) had been shattered, but was still intact.

Adjacent to the kiosk I observed another bullet strike in a tiled support post. The tile had fractured scattering debris on the floor below it. The bullet strike was also facing in a southeasterly direction.

I continued walking through the food court to an escalator which provided access to the lower level of the mall. I observed the glass making up the east wall of the escalator had been shattered. An interior glass panel in the same area appeared to have been struck, but not damaged.

I continued walking in a southeasterly direction towards Macy's and my assigned victim; Mr. Forsyth. As I approached the area in front of Macy's where the decedent was located, I observed an AR-15 magazine on the ground which was covered by a makeshift placard. The magazine was east of the decedent near a kiosk in front of Zales Jewelers. I also observed several other makeshift placards in the area which were covering spent bullet casings and bone fragments.

I met with Detective Bray who was already standing in the area. Detective Bray alerted me to some of the casings and other evidence which had been located prior to our entry.

I observed that a blue colored sheet had been placed over the decedent. The decedent was lying on the ground with his feet in a southerly direction (towards Macy's) and head in a northerly direction (towards the food court). The decedent was lying just east of a "Coastoms" kiosk.

The sheet atop the decedent was not covering his head and I could see he sustained a massive wound to the top portion of his head. There was a large pool of partially coagulated blood extending to the north of the decedent.

From my vantage point in front of Macy's, I could see Criminalist Martin to the west videoing an additional victim just outside of a Best Buy Mobile store. This victim was later identified as Cindy Yuille. I could also see north into the food court area where I had previously observed the damaged escalator glass, advertisement kiosk and tiled support post. To the east of this location was a Zales Jeweler Store and the promenade connecting to the easternmost stores.

West of the Coastems kiosk I observed a smaller grouping of shell casings which had also been covered with makeshift placards.

I continued videoing eastbound down the main promenade of the mall. Outside of the Macy's Home Store I observed an additional AR-15 magazine loaded with an unknown number of .223 rounds. The magazine was covered by a janitor's yellow "caution" placard. I continued east down the promenade and down the escalator to the first level. There I observed numerous officers standing near a doorway leading into a service hallway just north of JcPenney's. The door was marked as "13".



I approached the doorway and could see one male subject who had sustained a massive head wound. I learned that this subject was identified as the suspect; Jacob Roberts. I observed a white hockey style mask lying on the floor near Roberts as well as an AR-15 rifle. Roberts was also wearing a black colored tactical vest. Oregon State Police were responsible for processing this portion of the crime scene.

Continuing back out into the mall area, I observed additional small droplets of what appeared to be blood on the tile floor just outside of the JcPenney's store. The droplets had also been covered with makeshift placards.

I went back up the escalator and met up with Criminalist Finn, Canby Evidence Technician Don Hemstreet and Detective Cate. We entered the second level service hallway just west of JcPenney's through doors marked with "13". We walked down a set of stairs and into the corresponding lower level service hallway. From there we were able to walk in an easterly direction; eventually arriving at the suspects location.

I then returned to the area near where victim Cindy Yuille was located and met up with Criminalist Martin. Criminalist Martin, Evidence Technician Don Hemstreet and I walked back through the mall replacing the makeshift placards with numbered evidence placards.

We then looked for additional bullet strikes and bullet fragments in front of the Best Buy Mobile store and food court area. A bullet hole was located in a thin plastic sign in front of the Best Buy Mobile store which was marked as "A". An additional strike was located near the base of the Best Buy Store door frame and labeled as "B".

There was a large amount of broken glass on the floor in this area from the approximate ½ inch thick glass door of the Best Buy Mobile store which had been shattered. Several Criminalists sifted through the glass, but were unable to locate any bullet fragments. An additional glass panel adjacent to the door which fronted the store was also struck and shattered, but remained intact.

A bullet hole was located in a bathroom doorframe and door just north of the food court. This was later marked as "C". I placed a trajectory rod through the door frame and into the corresponding hole in the bathroom door and observed it pointed south; back in the general direction of where Mr. Forsyth was located.



It was decided that Criminalist Finn and Criminalist Martin would continue with the scene processing and that I would go off duty for the night so I could attend the suspect and victims post mortem examinations the following morning. *Refer to my separate Post Mortem Examination report for further details.* I cleared the scene at 2203 hours.

*Refer to Criminalist Finn's and Criminalist Martin's report for additional details regarding scene processing on the night of 12/11/2012 and early morning of 12/12/2012.*

12/12/2012 at 1300 hours, I reentered the mall with Criminalist Finn, Detective Juker and Sergeant Swanson. We met with Detective Cate, and Detective Krummenacker who were already inside. Criminalist Martin also joined us a short time later. We all walked through the scene again attempting to locate any evidence which may have been overlooked the previous night.


Two additional bullet holes were located on the east wall of the Zales Jeweler's Store which were partially hidden by a holiday wreath. Utilizing trajectory rods, we were able to determine the bullet paths extended through a corresponding service hallway and into the Tilly's store which was east of the Zales Jeweler's Store and hallway.

In the Tilly's store I observed that a manikin in the front window had been struck in the left shoulder with one of the rounds. The second round was unable to be located. Two bullet fragments were however located on the floor of Tilly's just east of the manikin and entrance holes. Those fragments (items #34 and #35) were photographed and seized as evidence.

I exited the mall at 1505 hours and returned to the CCSO ID office.

On 12/17/2012 at 1000 hours, Detective Voss of Gladstone Police Department came to the CCSO ID office and gave me two items of evidence he had previously collected; a compact disc of a recorded interview he conducted with Nicolas Meli and the sweatshirt worn by the third victim, Kristina Shevchenko. I signed the appropriate paperwork to transfer the property and turned the items over to Clackamas County Property Control personnel. *Refer to Detective Voss' report for further details.*

**NARRATIVE:**

On 12-11-12 at about 3:31pm, I heard dispatch say there was a shooting at the Clackamas Town Center mall, (12100 SE 82<sup>nd</sup> Ave, Happy Valley). Dispatch continued to report that a masked gunman was shooting a rifle inside the mall, near the Macy's Home Store.

I responded and arrived at about 3:34pm and parked near the JC Penny's upper level parking lot, just east of the Macy's.

Initially, I did not have any police with me, but saw Deputy Steve Shelly forming a group near Macy's. Two unidentified West Linn officers and Reserve Deputy Hilton joined me as we made entry in through JC Penny's.

We received reports that the suspect was last seen in the corridor hallway near Macy's and possibly headed towards JC Penny's. I located another group of deputies and we then divided into groups to hunt for the suspect.

My group consisted of Deputies Juker, Cate, O' Keefe, Reserve Hilton, and Senior Trooper Fosburgh. We searched the hall behind several stores and came to the area of Gentle Dental and I could smell the odor of gun powder. We rounded the corner that leads to a set of doors that enters the lower level of the mall near JC Penny's.

I heard Deputy O'Keefe begin verbally challenging someone to show their hands and then he said something like, "He looks 12-44". My position was rear guard and could not see what he was doing initially and then quickly learned that the shooter was deceased from an apparent self-inflicted gunshot wound to the head.

I noted a white hockey style face mask and a black in color AR-15 style rifle. I also noted the shooter was wearing a black in color tactical style vest that had at least one 30 round ammunition magazine on it. I also saw a spent casing on the floor, near his body.

Dispatch was notified and Deputy O'Keefe and I remained as crime scene guard and sent the others on a continued search as there were initial reports of more than one shooter. I cleared when I was relieved by supervision (about 6:03pm). At no time did I touch or move anything related to the crime scene.

### ACTION TAKEN

On December 11, 2012 at about 3:34pm I responded to the Clackamas Town Center, located at 12100 SE 82<sup>nd</sup> Ave. Happy Valley, OR regarding an active shooter. Dispatch broadcasted there was a suspect inside the mall shooting people near the food court. Dispatch received information that the suspect was a younger male wearing a white hockey mask, black shirt and unknown colored pants carrying an assault rifle.

I arrived on scene in the parking lot of Clackamas Town Center near the main entrance to the food court. I quickly exited my patrol vehicle and met up with Sgt. Fryett, Officer Huot and Officer Maple who were also on scene. Sgt. Fryett, Officers Huot, Maple and I formed a "hunter cell" and approached the main entrance to the mall near the food court. I noticed there were several people still making their way out of the mall as we entered. Our hunter cell entered the mall and proceeded across the food court toward the main entrance to Macys on the second floor. As we crossed the food court I noticed there was broken glass on the ground near the main corridor of the mall. Dispatch advised there may be more than one shooter inside the mall.

When we reached the main corridor of the mall turned right toward Sears and continued to clear the west corridor of the building. As we turned the corner toward Sears we observed a female subject lying on her back in front of the Best Buy Mobile store. I noticed there was a large amount of blood on the ground around the female. I also noticed there was a large amount of broken glass on the ground around the female. As we got closer to the female it was confirmed she was deceased. Our hunting cell passed by the deceased subject and continued to clear the building.

We came to the "Justice" store, located on the second floor and found it to be unsecured. We cleared the business back to the store room located at the back of the store. The door leading into the back store room appeared to be barricaded. I held on the door leading to the store room inside Justice, while Officers Huot, Maple and Sgt. Fryett continued to clear the mall. Eventually I received

assistance from Detective Dolan and Deputy Manly in clearing the back store room of the Justice store. Hiding inside the storage room of the Justice store we located approximately twenty people both employees and patrons of the Justice store. We escorted the subjects from the Justice store to an exterior door where they were met by officers waiting outside.

We continued to assist in evacuating people who were locked down inside businesses located on the second floor on the west wing of the mall. We stayed in position on the second floor of the mall on the west corridor until the SWAT teams arrived and began slow clearing the building.

### ACTION TAKEN

On December 11<sup>th</sup>, 2012 around 3:34pm I responded to the Clackamas Town Center located at 12100 SE 82<sup>nd</sup> Ave, Happy Valley, OR on the report of an "active shooter." Dispatch reported that there was a subject inside of the mall, wearing a hockey mask, and black shirt that was shooting people with an "assault rifle." Dispatch received several calls regarding the incident, some of which reported there were possibly as many as three shooters.

I responded to the Town Center with several other OCPD units. I parked on the south side of the buildings near the REI store. With my AR-15 patrol rifle deployed I entered the building at the lower main entrance, between Macy's and the Barnes and Noble Book Store. I met up with members of CCSO, Smith and Martin, to form a three man hunter cell. We preformed a search of the businesses on the south elevation of the lower level, from the main entrance near Macy's towards the JC Penny Store at the East end of the mall.

Our Cell searched several businesses prior to reaching the JC Penny store at the east end of the lower level. Once reaching the JC Penny store our cell joined up with several other law enforcement personnel. We were split up into four larger search groups and searched the mall heading west towards the food court. I assisted in searching several stores on the lower level from JC Penny to the central escalators.

During that time I assisted in the evacuation of several large groups of shoppers that had taken cover in the rear of many of the stores. Myself and several other searchers cleared several businesses during that time.

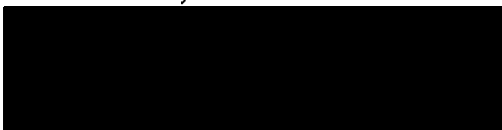

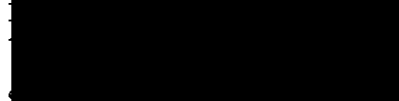

**ACTION TAKEN**

On 12/31/12 Sergeant Anderson gave me an email from the tip line, set up to receive tips for the Clackamas Town Center shooting, and asked me to contact the person making the tip. I read the email which mentioned Len Yates as the R/P. Mr. Yates stated that he knew someone known to him only as "Ben" who he thought could have been capable of the Town Center shooting until the identity of the shooter was made known to the public.

I contacted Len Yates by phone and asked him to tell me about the information that he had to provide. Mr. Yates told me that he met someone known to him only as "Ben" through a mutual friend Robert Hannington. Mr. Yates told me that he has met with "Ben" in the past and has been trying to bring the Gospel to him because "Ben" is a staunch Atheist.

Mr. Yates stated that Robert Hannington has witnessed that fact that "Ben" has firearms and he is a convicted felon. He told me "Ben" is terminally ill and hates the police and has mentioned harming others. "Ben" had looked into Death with Dignity but backed out. Mr. Yates told me that he knows that "Ben" lives near the Clackamas Town Center but didn't know where specifically. He told me that Robert Hannington knows "Ben" and could provide that information.

I called the phone number Mr. Yates provided for Robert Hannington and left a voice message. I have not heard back from Mr. Hannington.

I checked CLASSWEB for the nickname "Ben" and found numerous subjects mentioned with that nickname and was not able to determine if any of them were the "Ben" in question.

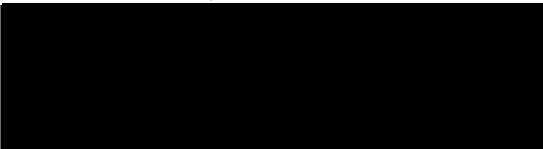

**ACTION TAKEN**

On 01/03/13 at about 1500 hours I was asked by Detective Copenhaver to follow up on a tip line report regarding the Clackamas Town Center shooting investigation. He provided a report prepared by Det. J. Rose of Tualatin Police Dept. detailing information provided by John Sarkissian of Clackamas.

Mr. Sarkissian told Det. Rose that he found an anonymous posting on Tumblr and was able to trace that posting back to [REDACTED]

On 01/04/13 I contacted Mr. Sarkissian by phone on and asked how he tracked the Tumblr posting which showed links to [REDACTED] Facebook account. He told me that the Tumblr posting led him to the 4Chan posting. Mr. Sarkissian told me that he knows that [REDACTED] was the first person to post the photo of the mall on Tumblr with the caption "Tomorrow. Watch the news, Clackamas Town Center Mall" because it shows he was the first to post it.

On 01/04/13 I contacted [REDACTED] by telephone and left a voice message for him. At about 1045 hours I had received a message on my voice mail box from Mr. Torres requesting me to call him back. I contacted Mr. [REDACTED] by phone. I introduced myself and explained to him that I was following up on information regarding his posting on Tumblr. Mr. [REDACTED] told me that he was not the original person who posted the information on 4Chan but he had seen it reposted on 4Chan the day before the shooting.

He told me that people were not taking the threat seriously and responding to the person who posted it with comments like "Oh you're not going to do anything". He told me that he heard the next night that the Town Center shooting occurred and he reposted the 4Chan posting on his Tumblr sight out of concern for people. He told me that he wanted people to know what this person had threatened and not to just assume it wasn't serious.

Mr. Torres told me the only intent he had by reposting the comment was to help warn people and he has no idea who originally posted the information on 4Chan because all the postings there are anonymous. Mr. [REDACTED] also told me that the 4Chan sight is an image board where anonymous persons can post photos and or comments, but if there is no activity on a post it is then deleted after a short period of time and there is no trace of the information.

Lionel Tate said he was loading up items into the car. He said he looked up and saw the suspect approaching them. He said the rifle was partially concealed under his arm. The suspect slowed, looked at them and then took off running. Lionel said he thought the guy was

On 12/11/12 at approximately 1529 hrs I assisted the Clackamas County Sheriff's Office with an active shooter situation at the Clackamas Town Center, 12100 SE 82<sup>nd</sup> Ave in Happy Valley (See original reports for details).

After the incident was over, and I had put my gear away I was tasked to conduct interviews of witnesses who were brought over to the command post at the east end of the mall parking lot.

There, I first spoke with Mr. Justin Langroodi at approximately 1810 hrs. Mr. Langroodi told me he was at work in the Hollister store in the mall when he heard four to five gunshots and saw customers running into his store to get away. Mr. Langroodi said he closed and locked the gates to his store and he and approximately 18 other people hid in the backroom until the police arrived and escorted them out of the mall.

Mr. Langroodi didn't see the shooter or any of the victims and only heard the gunshots. I then concluded my interview.

On 12/12/12 at approximately 0900 hrs I called and spoke to Mrs. Lori Alexander. I had briefly spoken to Mrs. Alexander the night before at the scene but she was unable at that time to give a statement as she had injured herself trying to exit the mall but she gave me her card with her information on it so she could give me a statement of what she saw/heard at a later time.

Mrs. Alexander told me her and her friend were waiting to get onto the elevator just inside the food court and across from Macy's clothing store when she said she pushed the button for the elevator and "All hell broke loose."

Mrs. Alexander said she knew it was gun shots based on her past experiences (She is a retired police officer) and the gunshots were so close the noise made her ears ring. Mrs. Alexander said as soon as the doors opened her and her friend crawled into the elevator, closed the doors and hit the button to go to the lower floor.

Mrs. Alexander said she continued to hear the gunfire while still in the elevator. Once the elevator reached the lower lever, they exited the elevator and went to the mall manager's office where they were eventually let in (The doors were locked) after repeated pounding on the door. Mrs. Alexander said she stayed in the manager's office until the police arrived and escorted them out of the mall.

I asked Mrs. Alexander if she saw anyone get hit by the gunfire or if she saw the actual shooter but she said she didn't. Mrs. Alexander did say the mall manager was watching the security cameras and narrating what was going on while they were there hiding but she never saw what happened either live or on the security monitors.

I gave Mrs. Alexander my information and asked she call me if she remembered anything else.

Later in the day, I was tasked to follow up and interview people who had called in to the CCSO Tip line with things they had seen/heard before and during the incident.

First I called and arranged to meet Ms. Katherine Dieringer (CCSO Tip Line Report #726-65) at the Starbucks, 14669 SE Sunnyside Rd in Happy Valley at 1245 hrs. Ms. Dieringer and I spoke in private and she told me she was in the perfume department at Macy's when she saw the suspect run by her towards the entrance to the mall.

Ms. Dieringer told me the guy she saw running was wearing a plain white mask, had dark brown hair and dark eyes. She said he was also wearing all black clothing and had what she thought was a bullet proof vest and had a rifle with him.

Ms. Dieringer said she thought it was weird and didn't really know what to think when about 10 seconds later she began hearing gunshots. Ms. Dieringer said she initially froze and then began to run when her boyfriend, Mr. Sean Boyle grabbed her arm and they ran out the west entrance of Macy's into the upper level parking lot. Ms. Dieringer said as they were running she was telling people who were entering the mall to turn around and leave.

Ms. Dieringer said when she looked at the suspect she could tell he "Was on a mission" as he didn't make eye contact with her as he ran past her. I asked her how far away she was from the suspect and she told me approximately ten feet because as she saw him running and carrying the gun she got moved further out of the way.

I asked Ms. Dieringer for more detail as to where she was standing at the perfume department when she saw the suspect and was able to determine she was standing in the aisle that leads from the south parking lot into the mall on the west end of the store.

I gave Ms. Dieringer the phone number for the DOJ Victim's assistance and talked to her about talking to someone about what she experienced etc. I also gave Ms. Dieringer my business card and asked her to call me if she remembered anything else.

At that time, I spoke to Mr. Boyle who was not only with Ms. Dieringer the day of the shooting but came with her to speak to me as well.

Mr. Boyle told me the same information as Ms. Dieringer (They were in the west aisle of Macys near the perfume department) when he saw the suspect running towards them from the south doors that lead into the south parking lot.

Mr. Boyle told me he first noticed the mask the suspect was wearing and said it wasn't a hockey mask like the news is reporting, it was just a white circular, cheap, plastic mask with holes for the eyes etc. I asked Mr. Boyle how far away he was from the suspect when he first saw him and he said he was approximately 10 to 20 yards away.

Mr. Boyle said he continued to watch him and noticed when he was about five yards away that the suspect was carrying a rifle. Mr. Boyle said he stepped out of the way of the suspect as he was running but the suspect actually brushed by him as he ran.

I asked Mr. Boyle if the suspect actually knocked him out of the way or anything as he ran by and he said no, their clothes just brushed against each other. Mr. Boyle then told me he was looking at the rifle as the suspect ran by and was trying to determine if the rifle was an airsoft or not when he heard someone near Ms. Dieringer say something about thinking it was a "Flash mob."

A few seconds later, Mr. Boyle said he heard five to six gunshots and that is when he grabbed Ms. Dieringer and they ran out the west entrance to Macy's. Mr. Boyle told me he didn't see any other weapons on the suspect other than the rifle he was carrying.

Mr. Boyle gave me the same description of the suspect as Ms. Dieringer did however, he told me he noticed the vest the suspect was wearing was very thin and didn't think it was actually a bullet proof vest but it was definitely some kind of tactical load bearing vest.

I talked to Mr. Boyle about the DOJ Victim's assistance information I gave Ms. Dieringer and also gave him my business card so he could call me if he remembered anything else.

I then cleared.

At that time, I called and spoke to Mia Skourtis (CCSO Tip Line Report #726-8) and made arrangements to interview her at her place of employment, Portland Providence at 1345 hrs. Mrs. Skourtis told me she was in the fragrance section of Macy's when she saw a male wearing all black clothes and a white hockey mask with a rifle across his chest running through the store towards the mall.

Mrs. Skourtis told me the suspect was running straight ahead and wasn't looking side to side. Mrs. Skourtis said, "He had a destination" he was going to.

Mrs. Skourtis said once he passed her she went back to shopping because she thought it was a dance crew or something similar and approximately 10 seconds later she heard six to seven gunshots. Mrs. Skourtis said at that time she ran out the west upper level entrance from Macy's into the parking lot.

I asked Mrs. Skourtis how far away was she from the suspect when he ran by and she said she was within a couple of feet. Mrs. Skourtis said, "He had a plan to do what he was doing." While talking with Mrs. Skourtis some more, I was able to determine she was standing near the west aisle in Macy's that leads through the store from the south parking lot to the mall entrance. I told Mrs. Skourtis about the phone number for DOJ Victim's Assistance but she told me she was fine and didn't need to talk to anyone about the incident etc. After I gathered Mrs. Skourtis information I cleared.

At approximately 1445 hrs I was able to speak to another witness, Mr. Daniel Beaudry after I had previously left him a message. Mr. Beaudry was in Molalla and wasn't available to meet in person at that time so I asked him what he had seen.

Mr. Beaudry told me he and his wife, Mrs. Angela Beaudry along with their four year old son, Noah, just finished eating in the food court when they saw a "Suspicious" looking subject walk into the mall from the north doors near the movie theater.

Mr. Beaudry said the male was wearing all black, was approximately 5'7" tall, had a hoodie over his head along with a mask that covered just the subject's nose and mouth that appeared to have some kind of skull design on it. Mr. Beaudry said the subject also was wearing a backpack.

Mr. Beaudry said approximately five to six minutes had passed after seeing the subject when they decided to go down the escalator from the food court to the lower level. Mr. Beaudry told me approximately 30 to 40 seconds after reaching the bottom level of the mall they heard gunshots. Mr. Beaudry told me at first he thought it was windows breaking above them but they soon realized what it was so he carried his four year old son and the three of them ran to the Macy's home store and then out of the mall.

I asked Mr. Beaudry if he had seen the shooter or had seen anyone get hit but he said no. Mr. Beaudry still seemed shaken up about the incident and he said his wife is shaken up as well so I talked to him about the DOJ Victim's Assistance information I had. Mr. Beaudry said he wasn't in a place to write the number down but would look it up when he got home. I told Mr. Beaudry if he couldn't find the number to call me back and I would get it to him, we then hung up.

I attempted to contact other people who called on the Tip Line as well but never received phone calls back to arrange an interview. Those people are: Alina Pavlenko CCSO Tip Line #726-36 (I was able to determine a good phone number for Alina but never received an answer or call back), Ronald Joseph

I attempted to get more Tip Line Reports but was told there weren't any more ready at that time.

On 12/14/12 Detective Atkeson and I were tasked with assisting in requesting/obtaining video surveillance from all the stores at the mall and also to be there to interview any employees returning to work who had seen the incident but hadn't been interviewed yet.

During the course of requesting/obtaining surveillance video from all of the stores on the lower level of the Town Center, I only spoke to one other witness who was there when the shooting happened, Ms Rebecca Hale.

Ms. Hale told me she was at work at the Disney Store when she heard gunshots coming from the mall. Ms. Hale said she started pulling people who were close into the store and then she shut and locked the gate. At that time, Ms. Hale had everyone move to the back of the store where approximately 18 people including herself, hid in a store room until the police let them out.

I asked Ms. Hale if she saw the shooter or any of the victims but she said no. We then cleared.

**ACTION TAKEN**

On 12/12/2012 at 1100 hours I received an after action briefing from CCSO Sgt Anderson. I was assigned to follow-up on "eye-witness" tips that were received via the CCSO Tip hotline or other methods. I then met in person or contacted the following witnesses via telephone:

**TIP REPORT #726-19**

At about 1331 hours I called MOORE and asked her to tell me what she saw regarding this case. MOORE told me that she was working in the Macy's store on the 2<sup>nd</sup> floor about 1/3 of the way to the food court on 12/11/12 when she heard someone running through the store. She looked up and saw a man with a white mask and a gun running by her location. She told me that she heard gunshots and hid in the back area of the store.

**TIP REPORT #726-20**

At 1453 hours, I contacted LEAGJELD by phone and asked her to tell me what she saw regarding this case. LEAGJELD told me that she as at the Clackamas Town Center on 12/11/12, and was leaving around 1510 hours when she saw a man dressed in a black trench coat, wearing black pants with a bandana covering his face. She had no other information.

**TIP REPORT #726-21**

Unable to contact RP as there was no phone number or address. Databases yielded no current information.

**TIP REPORT #726-23**

At 1318 hours I called HAY and spoke to him by phone. He told me that he and his wife were in the food court area at the Clackamas Town Center on 12/11/12 when the shooting happened. HAY told me that he and his wife had just gotten coffee at the Seattle's Best stand and sat down near the escalators directly across from Macy's on the 2<sup>nd</sup> floor. He told me that he heard the shooting start and his wife fell to the floor and the glass shattered at the escalator. He told me that he was in a wheel chair and he tried to move rapidly out of the way. HAY told me that he saw the suspect emerge from the Macy's and begin firing. He told me that that the man fired 2 shots and then paused and then fired 6 more shots. HAY told me that he saw the man run towards the Seattle's Best Coffee stand and then head north out of sight. HAY described the shooter as having a white mask covering his face, dark hair, wearing a dark vest over lighter clothing and he had a semi auto rifle.

#### TIP REPORT #726-27

At 1339 hours I contacted BOSTROM by phone and asked her to tell me what she saw regarding this case. BOSTROM told me that she was working at the Barnes and Noble store inside the Town Center and about 1 hour before the shooting, she saw a man in the store with a handgun in a holster on his waist. She told me that she did not know this man's identity, but he did not match that of the shooting suspect from what she saw on TV.

#### TIP REPORT #726-28

At 1340 hours I called and spoke to PATTY, and he told me that he was working in the Macy regular store on 12/11/12, near the Chipotle entrance, when he saw a man with a gun run through the store towards the food court. He told me that the man appeared to have on a bulletproof vest with dark pants and a mask. PATTY described the man as being 5'9" - 5'11" tall. PATTY told me that he heard the man say something similar to "I am the shooter" as he ran by. PATTY told me that he heard shots being fired and he left the store.

#### TIP REPORT #726-68

At about 1220 hours I called BOHANNON and she told me that she owned the Oil & Vinegar store at the Clackamas Town Center. She told me that they may have video surveillance of the shooting incident. She also told me that one of her employee's, "Ann" saw the shooting incident and told me that Ann's phone number was [REDACTED]. I called Ann and left a message for her to call me back. I did not hear back from Ann. I gave the video surveillance information to Joyce Naggy, who latter retrieved the video.

#### TIP REPORT #726-67

At 1245 hours, I contacted BATES at her residence, [REDACTED] Ave. She told me that the suspect in this case, ROBERTS, lived across the street from her and that she saw ROBERTS load up a guitar case on the day of the shooting. She told me that on 12/11/12 at about 1330 hours she had just come home from the store and was taking items out of the trunk of her car. She told me that she saw ROBERTS come out of his house with a guitar case and hurriedly got into his green Volkswagen car and left. BATES told me that she didn't remember seeing ROBERTS with a guitar case or other musical instruments before that date. She told me that she knew ROBERTS as a quite person and only occasionally saw him coming or going from the residence.

### ACTION TAKEN

On 12/11/12 at approximately 1529 hrs Detective Sgt Tonkin, Detective Atkeson and I were in the Detective office at WLPD when we heard CCOM dispatch units to a shooting at the Clackamas Town Center, 12100 SE 82<sup>nd</sup> Ave.

I heard CCOM advise very soon after the initial dispatch that they have information this was now an active shooter incident and Sgt Tonkin, Detective Atkeson and I left the PD to assist.

On the way to the Town Center, I heard updates regarding the description of the shooter and his last known location (Possibly the Macy's Home Store) as well as locations where other officers were arriving. Since most officers sounded like they were arriving on the east side of the mall and the shooters last location was near the home store I went to the north side of the mall and parked near the movie theatre which is just west of the Macy's Home Store, at approximately 1535 hrs.

There, I met up with other officers who had arrived at the same time as me and we entered the mall through the north doors leading into the food court. We then made our way to the front of Macy's clothing store at the upper level entrance to listen for indicators while people were still evacuating the mall.

There, I noticed one victim deceased on the floor as well as several .223 caliber shell casings and at least one empty AR-15 style magazine on the floor in the aisle leading towards JC Penny's. The group I was in began clearing stores and corridors between Macy's and JC Penny's but after a few minutes we heard a group of officers to the west of us towards Sears verbally challenging someone and it didn't sound like they were complying so we changed our direction and headed that way to assist.

## NARRATIVE:

At approximately 1:14am I was present while Detective Eggleston read the search warrant to Mr Dahrens and Ms Eheler in the living room. He asked for consent to also search the common areas of the house and they both agreed. Detective Eggleston present them with a 'consent to search card' that they both read and then Mr Dahrens signed it at approximately 1:17am. A copy is attached to this report.

## NARRATIVE:

On 12/11/12 after the initial mall scene was secure investigators opened a command post and began assigning interview duties. A detective, whose name I don't recall at the writing of this report, came back to the detective command post and said that the person s/he had just interviewed said they arrived to the mall on a TriMet bus at about 3:30pm and there was a white man on the bus wearing a mask. The man wore the mask as he walked into the mall using the entrance to the food court, which is a mall entrance directly across from where the shooting occurred. (there is a separate report on this interview, but I have not yet seen it at the time I am writing this report.)

Contact was immediately made with TriMet through one of the Transit Police officers and that bus was identified. It was sent directly to the TriMet bus garage so that the surveillance video could be pulled off. I believe that a Portland Police officer was assigned the task of going to TriMet headquarters, collecting the video, and then return it to the detectives' command post.

At approximately 7:00pm (and this time is very approximate-it could have been later) the video arrived at the command post, along with three still photos printed from the video. I loaded the disk in the computer and played the video. The unknown man got on the bus in Oregon City and off at the mall. At approximately 15:09 hrs (3:09pm) you can see a white male who is standing near the front of the bus remove a mask from his jacket pocket and put it on his face.



The mask seems to be a pliable material, since it looked like it was folded in his pocket. The mask is white with some type of black pattern on it.

When he boards the bus the unknown man is wearing a jacket and large headphones. During the trip the man removes his jacket and can be seen wearing a dark colored tank-top shirt. He also seems to be using an iPod or iPhone-like device. He puts his jacket on and from the jacket pocket removes the mask.

The video did not show this unknown male carrying a rifle or anything that could have concealed a rifle. Investigators began to consider that this unknown male was either an accomplice to the actual shooting suspect or that this was the shooting suspect and he had pre-staged the rifle at the mall or had an accomplice hide the rifle at the mall for him.


Initial reports from those who had contact with the deceased suspect was that he had only what he was wearing - no wallet, phone, or large headphones like seen in the bus video. An investigative team was sent back into the mall with the task of taking some photos of the deceased suspect to try and determine if these two individuals were the same person. When they returned to the command post the photos showed that the mask on the deceased suspect was a plain white rigid type mask, like an old-style hockey goalie would wear.

Investigators agreed that while it was too early to rule out this unknown mask-wearing bus rider as involved in any manner, he was not the actual suspect who did the shooting.

A few days after the incident, the CCSO Video Forensics Unit used the footage to create a few enhanced still photos of the person for use in the ongoing investigation. The disk of the new images along with the video footage disk was submitted to the CCSO Evidence & Property Room.

UPDATE: As of 12/24/12 the mask-wearing unknown white male has not yet been identified. I have not yet read any tips or reports involving a person who states they were the masked person on the bus. The investigative team has made attempts to identify this person while taking measures to prevent the general public from thinking that there is a second outstanding perpetrator:

- His non-mask photos have been shown to the friends and family of suspect Roberts and no one recognizes him as a friend of Roberts'.
- The photos have been posted on the CCSO website seeking tips.
- The photos have been sent to the Oregon City Police in hopes that he is a frequent bus rider that might be contacted at the transit center.
- The photos have been sent to the Transit Police in hopes that they see him riding a bus or train.

### NARRATIVE:

On 121112 I was assigned to the Clackamas County Inter-Agency Task Force (CCITF) of the Clackamas County Sheriff's Office. At approximately 1533 hours I was leaving the Clackamas County Circuit Courthouse in downtown Oregon City. While returning to my vehicle I received a phone call from PO Anderson. PO Anderson told me that there was an active shooter in the Clackamas Town Center (CTC), 12000 SE 82<sup>nd</sup> Avenue, Happy Valley, OR.

I ran back to my unmarked Police vehicle and began to drive towards the CTC. As I was operating an unmarked Police vehicle not equipped with lights and siren my response was delayed. While traveling on I-205 I overheard multiple teams of Officers/Deputies enter the mall looking for the gunman. After a



few minutes I arrived at the south side of the CTC. I donned my department issue tactical ballistic vest which has a cloth badge and the word "Sheriff" emblazoned across the back.

I had overheard reports that the suspect was last seen in the service corridors around Macy's. Moments later Deputies inside the CTC broadcast they had located a person whom they believed to be the suspect down with a gunshot wound to the head. The suspect also had a rifle and mask nearby. Despite this discovery Deputies/Officers continued to clear the mall and ensure there were no additional suspects.


Realizing no one was covering the service corridor exits in the area of Macy's (Upper southwest), The Mac Store, and the hair salon, Detective Fromme, Sergeant Naccarato and I set up to cover these exits and direct people out and away. We held these positions until the majority of mall patrons were safely evacuated and SWAT Officers had begun to slowly clear the interior.

Later, I went to the CCSO Command Post location. While at the Command Post Detective Sergeant Wold asked Deputy Brummett and I to relieve Deputy Bailey who was with the two deceased victims inside the mall. Deputy Brummett and I waited with the two victims until relieved by other Detectives and Crime Scene Investigators.

I then cleared the mall with this report.

### NARRATIVE:

On 12/11/2012 at around 1530 hours I responded with Deputy Alex Stidham to the Clackamas Town Center, 12100 SE 82<sup>nd</sup> Ave in Happy Valley for a reported Active Shooter incident. I responded from Oregon City to the location. While approaching the area Deputy Stidham was instructed to check in at the Command Post which was located at the MAX parking garage on the east end of the parking lot.

Once we arrived at the location I donned my external body armor and readied my shotgun. I then walked to where other officers were meeting and waited for instruction. When enough officers arrived at the Command Post to form a cell we were deployed to the cinemas to clear it and evacuate any citizens. We cleared and evacuated the cinemas without incident and returned to the Command Post.


Sgt. Wold then instructed Deputy Stidham and me to check the parking lot area around the mall in an attempt to locate any witnesses. We contacted several people in the parking lot who heard the shooting but didn't actually witness it. After checked the perimeter of the mall, Deputy Stidham and I returned to the Command Post and awaited further instruction.



Eventually we were told to clear the area and go home and rest in case we would be needed later.

NARRATIVE:

On December 11<sup>th</sup>, 2012 at about 3:30pm I was on duty, assigned to the Clackamas County Sheriff's Office (CCSO) Special Investigations Unit (SIU) working in the Oregon City area. I was advised by Sgt. Marcus Wold of an active shooter at the Clackamas Town Center (CTC) in Happy Valley Oregon. I responded to CTC and while I was driving towards the mall I monitored CCOM NET1 and overheard numerous updates by dispatchers and deputies arriving on scene which included reports of shots fired, a victim of a gunshot wound found deceased and one of the suspected shooters also found deceased. I overheard reports of the possibility of additional shooters.

I responded to the command center near the Tri-Met parking structure and was tasked with entering CTC as part of a four man cell with Sgt. Frank Schoenfeld (Canby PD) to clear the movie theater on the north side of the CTC complex and evacuate patrons of the theater. We evacuated three employees of the theater and over twenty patrons without incident. We searched each of the theaters and made sure they were clear.

After I completed this task I responded back to the command post. As I was walking back to the command post I observed a man and woman walking through the parking lot. The woman was limping and was being supported by the man. I contacted them both and learned they were husband and wife, Rick and Elise Data from Oregon City. Rick told me he and his wife had been outside Macy's when the shooting started and his wife had injured her ankle. Elsie appeared to be walking okay with assistance and told me she could make it to the command center. I escorted them both there; ensured Elsie got medical attention and then directed Elsie and Rick to the Tri-Met buses where witnesses were waiting to be interviewed.

Officer Dan Hanes and I attempted to locate additional witnesses who had not made it to the staging area. Officer Hanes and I drove then walked around the north side of CTC. We found about thirty people near the entrance to Nordstrom's. I contacted the group and learned they were all Nordstrom's employees waiting to re-enter the store and secure their departments. I learned that none of the people present had witnessed any of the shooting or the shooter, some of them told me they did hear gunshots. Officer Hanes and I briefly interviewed each person in turn. Amando Cabrera, Tony Villa and Paul Laurent told me they were all three together at the upper mall entrance where they heard between 10-20 gunshots each. Brittney Bugarin told me she was at the lower mall Nordstrom's store entrance and heard between 10-15 "rapid fire" gunshots. I talked to several other Nordstrom's employees who were inside the store, some heard a few gunshots others did not hear anything. I noted each persons observation or lack thereof above, next to their name.

I was directed by Detective Dan Kraus to contact Macy's loss prevention and obtain a copy of the security video of the inside of the Macy's store just prior to the shooting. S/A Brendan Dennard, Officer Dan Hanes and I went through the food court entrance of CTC. Officer Hanes was a former employee of Macy's and was in phone contact with the Macy's Loss




Prevention Manager. When we arrived in the mall we learned the tactical teams were still slow clearing towards Macy's and had not cleared the store yet.

We waited for the tactical team to clear Macy's then met with the loss prevention manager, Lara Larson. Lara told me she had made four copies of the security camera footage captured by the cameras in her store. Lara played the video for me. I observed a man wearing a white mask carrying and carrying an AR-15 style rifle enter through the second floor doors from the parking lot. The man sprinted towards the front of the store and the food court. Lara told me the next video she had of the suspect was of him entering the service corridor in front of Macy's near the food court. Macy's security video does no record sound.

I seized all four copies of the video Lara had made. I released on copy to S/A Dennard, I gave two copies to Detective Jeff Burlew and I later entered the remaining copy into CCSO evidence.

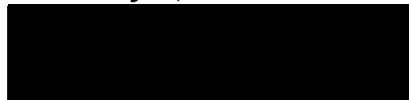

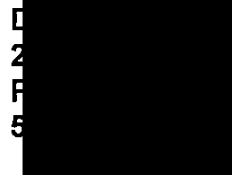

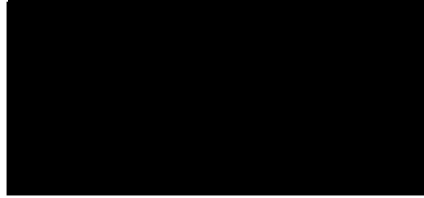

**McCammon, Heidi Thompson****NARRATIVE:**

On 12-26-12 at 10:12 am, I called Heidi McCammon regarding Tip #296 from this case. I identified myself to Heidi and explained my understanding was on the day of the Clackamas Town Center shooting she was at the Estee Lauder counter inside Macy's. Heidi confirmed this information and said she was with her daughter.

I asked Heidi what she saw and she explained she was facing east and the suspect had come from the south doors of Macy's. She first felt and heard running and it wasn't a little kid. She turned and saw a black gun first and it appeared semi-automatic. He was wearing a black vest that she thought looked like an air soft vest over dark clothes.

Heidi said she didn't see the mask but after he ran by, she saw the strap across the shooter's dark, wavy hair. She later talked to her daughter who is 18 and her daughter saw the hockey mask. Heidi said she told her daughter it was weird they allow air soft in the store. She then saw a lady next to them who was white and this lady commented she thought that was strange. Then the shooting started.

Heidi explained the shooter was booking, he was running and was by himself. She and her daughter immediately ran out the south doors of Macy's. She didn't hear any shooting in Macy's before she saw the guy running. She thinks he started shooting as soon as he exited Macy's through the security tag monitors.

I asked Heidi if the shooter said anything when he ran by her and she said he was dead silent and focused. He ran by them close enough that he brushed her daughter's arm. She saw the tip of the gun was up and in his right hand and his left hand was down low. She thought the shooter looked fit, like he was in shape.

I asked Heidi if she saw anything when she ran out the south doors. She said she didn't see anything suspicious, just everyone running. She did notice the bell ringer was gone when she left. She had been at the store about 10 minutes and the bell ringer was there when she arrived. She remembered commenting to her daughter how jolly the bell ringer was.

I asked Heidi if she noticed any vehicles and she said she didn't see any that were out of place. She remembers seeing about three other cars in motion when she was running to her car that was parked close.

Heidi said she didn't have anything else to add. She didn't know anyone involved in the shooting personally. I asked how many shots she heard. She said the shots were really fast and rattled off. Her daughter told her she heard one shot but her daughter took off running before she did. Heidi says she knew there was more than one shot but couldn't say how many.






Finally Heidi said she didn't hear any yelling or panicking as she was running, except as she was leaving one Macy's employee said get down get down.
