



At 12:11 pm Detective Fryett and I made contact at this kiosk at the Lloyd Center with a female employee. She didn't know where Miguel was as he was supposed to have been there earlier. She called Miguel and handed her phone to me. I identified myself to Miguel and explained I wanted to talk about what he saw posted on Facebook. Miguel said he would be there in an hour and gave me his cell phone number.

Since we were in Portland, Detective Fryett and I went to lunch at the mall. We then sat at the table and chairs next to the kiosk to wait for Miguel. I saw the female on the phone after she saw us and approached her at 1:15 pm. She told me Miguel has not shown up yet and he told her he would be there in 30 minutes. She added he has been saying that since 9:00 am. I left my card with her to give to Miguel.


At 1:20 pm, Miguel left a message on my voicemail advising he was there now and left his number.



Ms. Mix told me she heard the emergency exit alarm going off so she got up and went out the door and was in a service corridor and turned toward JcPenney to try to run out of the building.

Ms. Nix said as she neared the door she saw "blood all over the floor" and then she saw a person there lying next to a long black gun.

I asked Ms. Mix if she could tell me what the person was wearing or what they looked like. Ms. Mix told me she was unable to look at the person. Ms. Nix said she turned around and ran back to the Gentle Dental door and pounded on it asking to be let in.

Ms. Mix said she heard some discussion on whether or not to let her in and after a few seconds the door opened and she was brought inside the business.


Ms. Mix told me she didn't have anything else to add. When I evacuated the business Ms. Mix was escorted out with other patrons.

NARRATIVE:

On 12-11-2012 at about 1945 hours Detective Eggleston and I responded to the 7-11 located at SE 82nd Ave. and SE Flavel. PPB Officer Carol was on scene with Mr. Cates. Mr. Cates was reporting the theft of his AR-15 rifle from his home and thought his rifle may be the one that was used at Clackamas Town Center.

At our arrival I received the serial number and maker of the gun from Mr. Cates. I contacted the command post and spoke with Sergeant Anderson. I was told the rifle Mr. Cates was reporting is the same rifle that was used at the Clackamas Town Center.

Detective Eggleston and I interviewed Mr. Cates. (See report by Deputy Eggleston)

After the interview was complete we responded to **Least Section**. Portland. I rode in Mr. Cates car with him. Mr. Cates had agreed to allow Detective Eggleston and I look inside his home.

At our arrival Mr. Cates brought us into the house and took us to his living area which was in the basement.

I noted there was an empty rifle case and a loaded magazine for an AR-15 rifle. Mr. Cates told me these were for his rifle but his rifle had been inside his closet area. Mr. Cates showed me where the rifle had been. Mr. Cates told me there had been one full magazine inside the rifle but there had not been a round in the chamber.

Mr. Cates also noted there was a missing guitar case downstairs. I saw a guitar leaning against the wall in the entertainment room. Mr. Cates said the guitar had been inside a case.

Mr. Cates told me Mr. Roberts had given him an Xbox last night and told him he could have it. I checked the Xbox for stolen and it checked clear. I know an Xbox can be used to access the internet. I told Mr. Cates that I would like to seize the Xbox to have it examined by Computer Forensics. Mr. Cates told me that would be fine.

I gave Mr. Cates a receipt for the Xbox, Rifle case, Rifle magazine, and his original purchase receipt for the rifle. Mr. Cates had brought this receipt with him when he had originally contacted Portland Police about his stolen rifle.

Detective Paul Wade Clackamas County Sheriff's Office I noted Mr. Cates had ammunition for the rifle that was still at his residence.

Mr. Cates accessed his Facebook account and looked at Mr. Roberts's page. I didn't see any ominous postings by Mr. Roberts and the last posting had been November 30th, 2012 and referenced him moving to Hawaii.

Mr. Cates identified the other roommates that live in the residence but none of them were there at the time to contact.

Detective Eggleston and I thanked Mr. Cates for his help and cleared the scene.

On 12-27-12 at 9:15 am, I called Marilyn Smith in regards to Tip #250. Her husband Delbert had called in for her advising she works at Macy's, she saw the shooter run past her then heard the shots. A male answered the phone and advised Marilyn wasn't available and took my information for her to call back.

At 9:36 am Marilyn returned my call and we were able to talk. She confirmed she was working at Macy's when the shooting occurred and she still works there. She said it was difficult to go back to work after the shooting but it's getting better over time.

I asked Marilyn to explain what she saw on the day of the shooting. She saw the shooter come in the south entrance. She was working in the accessories department which is on the west side of Macy's near the south entrance. She was putting socks away.


Marilyn said she heard running and looked up. She saw the shooter who was six to eight feet away from her and he was running very fast. She and another co-worker watched him until they couldn't see him anymore as the aisle he was running on curved. Marilyn and her co-worker exchanged the words of did you see that and they both saw he was wearing a white mask, what they believed to be a bullet proof vest and he had a gun.

Marilyn said a customer said they should call security and before she could move, she heard shots. He didn't shoot in the area of Macy's that she could see but the shots were so loud it sounded like they were in the middle of the store. She confirmed she didn't see the shooting.

I asked Marilyn if the shooter was with anyone and she said no, he was alone. I asked if he said anything. She said no, it was like he was focused. She further explained it was like he had tunnel vision to the mall. He didn't look right or left, he came in and ran straight ahead. Marilyn said she heard a rumor that he told someone "I am the shooter" but she didn't hear it.

I asked Marilyn how many shots she heard. She said before she ran into the stock room there were 10 to 12 shots. Once she was in the stock room, she heard ten to twenty more then it all stopped.

I asked Marilyn if there were any other details she thought we should know and she said that was pretty much it in a nutshell. She saw the shooter, he ran, heard the shots then dead silence. Marilyn said she came out of the stock room and checked for anyone in a dressing room. There was no one there and she went back to the stock room and rejoined the girl from Sunglass Hut. This girl went to get her phone



then they went outside to the parking lot. Marilyn called her husband and said the time was 3:33 pm.

I thanked Marilyn for the information and advised she could call me at any time if she thought of anything else she felt was relevant. We then ended the call.

She thinks the shooter came down the escalator from the Nordstrom's end of the mall to get to the lower level because he didn't use the escalator by the food court.

Paige said she heard maybe 10 to 15 shots fired and it was really fast. The shooter was by him when she saw him. He didn't say anything. She thought he looked really pale and mentioned she is very fair skinned and he was paler than her. She thought this was weird because on the news, the shooter looked possibly Hispanic.


Paige said she didn't know the shooter or anyone involved. She lives in Arizona and was in Oregon a month to help at this store. Her job is to travel to their stores.



Lori confirmed she was at the gift wrapping table which was in front of the Macy's home furniture store. This store is located east of the food court, on the north side of the upper level.



While going through the food court, Lori saw people hiding under tables. There was lots of security, about every twelve feet who were very calm and helpful. They directed them out of the mall. Lori waited across the street by the apartments until she was able to retrieve her car and leave.

I asked Lori if she heard the shooter say anything. She said no, she just heard shuffling of feet and then a ping, no words. I asked how many shots she heard. She said the first round, maybe ten. The second round there were maybe ten more shots. She said there was only one person when asked how many people she heard referring to the suspect.

I asked Lori if there was anything else she thought we should know that she hasn't heard on the news or from others. She didn't think so except it all happened so quickly.





He heard a noise and went towards Zale's jewelry store. He looked across the way and saw the shooter in front of Morgan's jewelry. He saw the gun and saw the shooter run through Macy's on the upper level. It was the Macy's home furnishing store.

Terry said he saw the white mask and said he "was shaking it". I asked what the suspect was shaking and he said the "A15". He said he doesn't know much about guns and thought the suspect had a rifle. He heard it was really an A15.

Terry said the shooter was by himself. I asked how many shots he heard. Terry said he doesn't think it was 60 like he has heard people say. He thought he heard 15 shots. He described it as pop, five or six more then quiet then a few more shots.

Terry repeated he saw the white mask and dark clothes. The shooter looked back and forth, was shaking it and then he left. He didn't see another gun and thought the shooter looked to be by himself. He didn't hear any words out of the shooter's mouth.

Terry said he works at the mall at the Fred Meyer jewelry store on the lower level. He had nothing else to add and I thanked him for his time.



She thought to herself that no one can get here fast enough and then he started shooting. She didn't see the shooting, just heard it. Hannah confirmed she didn't see anything after he had ran past her.

I asked Hannah how many shots she heard and she thought about six. She ended up going to her manager's office with others. In the office, it was dead silence and they didn't even hear the announcements.

I asked Hannah if anyone was with the shooter and she said no. I asked if he said anything and she said no. I asked if she recognized him and she said no, adding he was running pretty fast.


I asked Hannah if she heard anyone say anything that was peculiar or noteworthy and she said no. She said she asked a co-worker if that was a real gun who answered that it can't be. I asked if there was anything else she thought we should know. She said to her it sounded more like pop, pop, pop not bang. She could tell he made it to the mall and was out of Macy's when he shot.







On 12-28-12 at 9:13 am, I called Shayne Atterton in response to Tip #103. His girlfriend had called in the tip on his behalf as he was refusing to call due to trauma. Shayne said he would talk to me and said he was there and saw the suspect start shooting. He was coming out of a jewelry store on the lower level and was walking towards the escalator to go up to the food court.

Shayne said he started running like everyone else. He went up the escalator and saw Steve who was shot in the head. He saw a magazine on the ground and told security about it. Shayne then left. I asked where the magazine was and he said in front of Zale's by a kiosk.

Shayne thought it was odd he didn't hear the shot when the suspect shot himself. He said the suspect was by himself. He saw his gun got stuck and it looked like he panicked. The suspect then started running.


I asked Shayne if the suspect said anything. He said not that he heard he just heard the gun shots. He thought it was a prank until he went upstairs and saw Steve. I asked if he knew Steve before or anyone else involved and he said no. I asked how many shots he heard and he thought maybe 15. He heard two shots back to back; there was a five second break and then the rest of the shots. When he went upstairs, there were shell casings everywhere.

I asked Shayne if there was anything else he thought we should know and he answered not really. We then ended the call.

On 12-28-12 at 1:02 pm, I called Cynthia Norberg in response to Tip #229. She told me she was upstairs at Macy's by the perfume counter in the main store. She is assuming the suspect went by her but she wasn't paying attention as she was smelling lotion. She is assuming this based on what she has seen in the news.

Cynthia said until she saw the news, she thought the suspect was in the mall and came into Macy's. She heard shouting from the suspect and then shooting. She heard yelling and then looked at the perfume lady. Cynthia said she has been back to the mall many times with family and friends to deal with this as she isn't going to let the suspect take her life away from her too. She repeated about looking at the perfume lady once she heard the shooting.

Cynthia then said the gun jamming lasted for a few seconds unlike what others are saying about this. She referenced hearing since the gun jammed, this saved lives and she doesn't believe it. She insists the gun jamming was too quick to have deterred the suspect from killing more people.

I was able to ask Cynthia how many shots she heard and she answered "a lot". She then explained she ran and fell down the escalator as she tried to jump over the side of it near the bottom. Once she got to the lower level, she ran out a side door. She got into a strangers car and then got out to run to West Coat Bank where they locked her inside.

Cynthia said it was after several days of processing what happened that she realized the shooter wasn't after her and at the time, she thought he was. She said the initial shots were loud but then they got softer as she was running away. She said she heard twenty shots by the time she got to the bottom of the escalator.

Cynthia went into a dissertation about the suspect continuing to shout get down and I'm the shooter. I confirmed with her she never saw the suspect and didn't know he had gone by her at the perfume counter. She insisted it was the suspect shouting and he was yelling words that weren't normal. She said the shots started and she knew there was no question in her mind what was happening.

Cynthia kept talking about the theories of the shooting and how what's in the news isn't accurate. She has a friend that worked next door to where the suspect worked who insists he would have never killed himself. She believes there is another motive to the shooting.

Cynthia then went into her theory that the suspect went into the mall with others to rob jewelry stores to go to Hawaii together. The suspect's job was to cause a



distraction so the others could do the robberies. After the suspect went in, he found his buddies didn't follow behind him so he killed himself.

I obtained Cynthia's contact information and she told me I should contact West Coast Bank as they would be able to tell me what she said when she was there. I thanked her for the information and ended the call.



On 12-11-12, at about 1530 hours, I was working in my cubical when I over heard Detective Mary Nunn say there was just a shooting at Macy's. I then heard Detective Nunn advise that the suspect was still shooting people in the Clackamas Town Center (CTC) Mall, and this incident was an Active Shooter.

I ran to my unmarked vehicle and responded to the Northeast corner of Clackamas Town Center, and parked near the North doors of JC Penny. I noticed Sergeant Kollias parked next to me in the parking lot. I put on my SWAT heavy vest and slung my rifle. Sergeant Kollias and I ran to the Northeastern doors where I could see Detective Juker and Deputy Kishpaugh. Sergeant Kollias and I joined Detective Juker and Deputy Kishpaugh to hunt the active shooter, later identified as Jacob Roberts.

Sergeant Kollias, Detective Juker, Deputy Kishpaugh and I encountered a JC Penny employee as we searched the upper floor of JC Penny. The employee indicated that Roberts had not entered JC Penny and the large doors between JC Penny and the mall had been locked. The employee unlocked the large doors and we continued searching into the main central common area of the mall.

At about 1540 hours, Sergeant Kollias advised our group had searched the upper level of JC Penny and were continuing to search the mall. We moved on the upper level of the main central common area toward the Macy's Home Store, but found a couple sets of double doors between JC Penny and Macy's that accessed a service corridor. Our group was joined by Deputy O'Keeffe, Deputy Eason, and two Oregon State Police (OSP) Troopers.

Our large group entered Service Corridor #13. As our large group quickly searched the upper level, we came upon a stairwell leading to the level below. The large group searched to the bottom of the stairs and separated at the bottom of the stairs.

Detective Juker, Deputy O'Keeffe, Deputy Eason, an OSP Trooper and I continued to search to the right, in Service Corridor #2. The Service Corridor zigzagged behind businesses, and led to the main central common area of the mall on the lower level in front of JC Penny.

As we rounded a corner, I could see a couple sets of double doors, a blue shopping cart, and a rifle in the middle of the hallway. The shopping cart was against the left wall and I could see a pair of shoes sticking out from behind the shopping cart. The shopping cart obscured the rest of the view of a body on the ground. As we continued closer, I could see more and more of the body on the ground. I could see there was blood on the barrel of the AR-15 style rifle; the deceased person was wearing dark pants, a black load bearing type vest with a loaded rifle magazine in it, a large pool of blood on the ground next to the head of the body, and a white mask in the pool of blood. The deceased matched the description of the active shooter/suspect.

The body was about ten feet from the double doors. I could see a mop bucket between the double doors and the body, and I could see the fluid in the bucket was red. I noticed a chair between the body and wall. The deceased had a gunshot wound to the head, and as a result the walls and floor in the hallway were spattered with blood and bone fragments from the deceased's head. I noticed in the area of the shopping cart were a live round and a spent case on the floor. The deceased appeared to be a young man, with short dark brown or black hair, spike type earrings, and was wearing ear plugs.

At about 1551 hours, I heard Detective Juker broadcast over the radio that we had located what appeared to be the suspect (later identified as Jacob Roberts) with a self inflicted gunshot wound, and was deceased. Deputies O'Keeffe and Eason remained with the deceased Roberts.

Detective Juker, an OSP Trooper and I carefully walked passed Roberts' body to the double doors so we did not disturb the scene. The double doors opened to the main central common area of the mall on the lower level, in front of JC Penny.

Detective Juker, an OSP Trooper and I waited briefly in front of JC Penny because we could see search groups moving toward us from within the mall, as well as additional police officers from various agencies entering the mall from outside. After a very short period of time, all of the teams came together with a plan to begin searching the upper and lower levels simultaneously for additional suspects, injured persons, and persons who had barricaded in stores or wherever they could.

I remained on the lower level with several police officers of varying rank from many different agencies. The large groups on both levels coordinated to mirror the search efforts on their respective floors, starting at JC Penny and moving into the mall. As the group on the lower level searched businesses and evacuated people that had been hiding; I met up with Sergeant Anderson, Deputy Rippe, Deputy Olsen and some other police officers and branched off of the larger group to search the lower level of Macy's.


During the search of Macy's, I heard a radio broadcast that all non uniform police officers needed to exit the mall because SWAT teams were going to be entering the mall to slowly search and clear the entire mall.

I made my way out of Macy's to the main central common area of the mall, with the other searchers. I walked up the escalator to the second level. I could see one of the windows at the top of the escalator was shattered out.

The top of the escalator opened up at the food court. I could see jackets on the backs of chairs, bags with purchased items inside, food on tables, and chairs knocked over. It appeared there were a lot of people in the food court that left in a hurry. From the edge of the food court, I could see a covered body in front of Macy's and another covered body in front of Best Buy Mobile. It appeared both bodies were covered by a blue blanket or sheet.

I exited the mall. I returned to my unmarked vehicle and removed my SWAT heavy vest. I checked in at the Command Post. At the Command Post, I was assigned to the scene involving the male victim (later identified as Steven Matthew Forsyth) outside of Macy's. Detective Nunn was assigned the scene involving the female victim (later identified as Cindy Ann Yuille) outside of Best Buy Mobile. Detective Lee was assigned the scene involving the suspect (later identified as Jacob Roberts) in Service Corridor #2.

Detective Lee, Detective Nunn and I coordinated with Crime Scene Investigators (CSI) from CCSO, OSP and the Portland Police Bureau (PPB). After the quick briefing, I returned to my unmarked vehicle and put on a ballistic vest. I met up with Detectives Lee and Nunn at the food court entrance of the mall with the other crime scene investigators.



I asked Deputy Lister to start a crime scene log at the food court entrance to the mall because I was not sure if a log had been started or not. Once Deputy Lister was there to record the detectives and crime scene investigators, we entered the mall.

At about 1834 hours, I entered the mall. I stayed at the back of the group because investigators at the front of the group were video recording and taking photographs. The teams assigned to each scene began to split up and go toward their area/scene of responsibility. I went across from the food court to the front of Macy's on the second floor. I could see there was a body that had been covered by a blue sheet or blanket. I could see the covered body had a substantial amount of blood surrounding the head in a pool on the floor. I noticed several empty shell cases on the floor between the body, and Macy's and Zales Jewelers.

Deputy Medical Examiner Tonsfeld was able to identify the male as Steven Matthew Forsyth from information inside Forsyth's pockets. Forsyth was wearing white shoes, brown socks, brown pants, brown belt, and a tan shirt. Forsyth appeared to have a gunshot wound to the head.

I noticed near Zales Jewelers was a large triangular sign stand with advertisements; the sign seemed to be in the path of the empty shell cases. At the base of the sign, I noticed a rifle magazine with some live ammunition in it and a live round on the ground near the rifle magazine.

I estimated the deceased female (identified as Cindy Ann Yuille) was about 40 yards from Forsyth's body. Comparing the location of the empty shell cases in relation to the damage (i.e. broken windows; and bullet holes in doors, pillars, and walls) and where the victims were, it appeared Roberts shot from in front of Macy's as he moved in the direction of Zales Jewelers.


I could see Yuille's body was surrounded by broken glass. There was a large window that appeared to have been shot out during the incident. I could see what appeared to be a gunshot exit wound on the front of Yuille's chest.

I learned from a search team there was possibly blood discovered in a back service corridor behind Eddie Bauer. I passed on the information to CSI so they could examine the service corridor to see if there was anything significant there.

I contacted Sergeant Anderson by telephone and provided him with an update of scene details. Sergeant Anderson advised me that Roberts' vehicle was located in the parking lot outside of Macy's on the South side of the mall. Sergeant Anderson advised me that video had been recovered from CTC security that showed Roberts entering the mall through the South entrance of Macy's wearing a mask and armed with a rifle.

Sergeant Anderson also advised me that the female victim (Kristina Shevchenko) that was transported to the hospital with a gunshot wound, was first discovered by police in the area of the REI store. Sergeant Anderson advised Shevchenko was believed to have been shot outside of Macy's in the area of the other victims.

At about 2050 hours, Detective Nunn and I went to the Southern Macy's entrance where Roberts' vehicle was parked, which was the same entrance where Roberts entered the mall.



Detective Nunn and I checked Macy's for any evidence left behind by Roberts. Detective Nunn and I did not locate any evidence inside Macy's at this time.

At about 2115 hours, I coordinated a meeting between Deputy Bailey with the CCSO CRAFT Team and Officer Ken Jones with PPB CSI to determine the best method of documenting the crime scene. The decision was made for CRAFT to not diagram the scene. OSP documented the scene where Roberts was found, while PPB CSI utilized a Leica ScanStation to document the scene from where Yuille was found through the mall to the service corridor where Roberts was located.

At about 2255 hours, I exited and signed out of the mall/scene and returned to the Command Post. Detective Burlew and I later provided a briefing of the scene and what was known to this point in the investigation to members of CCSO Command Staff.

While other investigators served a search warrant at Roberts' residence, Sergeant Anderson assigned me to contact a female regarding an internet post.

On 12-12-12, at about 0131 hours, I contacted Lisa Ommert by telephone. Lisa Ommert told me that when she searched Twitter by "# Clackamas Shooting" she found a link to http://imgur.com/a/elmJT. Lisa Ommert told me the link appeared to be a screen capture posting of someone going by "anonymous" posting that someone was going to shoot up the mall. Lisa Ommert told me the posting was dated 12-10-12.

I searched http://imgur.com/a/elmJT and found what Lisa Ommert was talking about. I printed the information and attached it to this report, and also used a program to save a screen shot. The screen shots taken were saved to a CD. A copy of the CD was made for the case file and the first CD was placed into CCSO evidence. I also forwarded this information on to the investigators assigned to organizing Tips so it could be further followed up on.

At about 0221 hours, I signed back into the mall/scene for a walk through of the scene with other investigators. At about 0259 hours, I exited and signed out of the mall/scene.

On 12-12-12, at about 1200 hours, Detective Krummenacker and I went to the Southern entrance to Macy's, where Roberts parked his vehicle in the CTC parking lot. Detective Krummenacker and I were going to walk through the mall in an attempt to locate additional evidence. Detective Krummenacker and I noticed a painted "X" in the parking lot, which we believed to be where one of Roberts rifle magazines was located. Next to the "X" was a live rifle round.

Detective Krummenacker took a measurement of the live round in relation to the "X", which was about 42 inches from the "X" on the mall side of the "X". I photographed the live round and Detective Krummenacker seized the live round and later transferred custody of the round to CSI Michelle Finn. CSI Finn advised me the live round was item #31.

I later saved the photographs of the live round to a CD, and made a copy of the CD for the case file. I placed the first CD into CCSO evidence.

At about 1216 hours, Detective Krummenacker and I went to the CTC food court entrance of the CTC mall and signed into the scene. Detective Krummenacker and I walked through

Macy's with Detective Juker, and CSI Finn and Shelley. Eventually another bullet hole was discovered inside Macy's. For details see CSI Finn's report.

As Detective Krummenacker, Detective Juker, CSI Finn and Shelley, and I walked the suspected path of Roberts we attempted to identify additional evidence. Eventually more bullet holes were discovered in Zales Jewelers. The bullets' paths went into Zales Jewelers, across the service corridor hallway behind Zales, and into a clothing store. For details see CSI Finn's report.

At about 1404 hours, Detective Juker and I exited the mall/scene. A short while later I returned to the mall, but Detective Krummenacker was in the process of signing out of the scene so I never went back inside.

No further information.



NARRATIVE:

On 12-13-12, at about 1450 hours, Detective Timeus and I went to the address Ct #147, Milwaukie, OR in an attempt to contact Tyler Eheler, who was reportedly a friend of

Jacob Roberts. At first the male that answered the door thought Detective Timeus and I were associated with the media and was not going to talk with us. I showed the male my police identification and the male invited Detective Timeus and I inside.

I introduced myself and Detective Timeus to Tyler Eheler and his mother, Kelly Eheler. I asked Tyler if we could speak with him separate from the other people inside the residence. I advised Tyler that I would like to audio record our conversation, and he agreed. The interview was recorded with Tyler's knowledge, and I also advised Kelly Eheler, and two others who were sitting in the living room that I would be audio recording.

I asked Tyler Eheler if Roberts gave him anything the day of the shooting. Tyler Eheler showed me a pink bracelet that he was wearing on his right wrist. Tyler Eheler took the bracelet off and told me Roberts gave him the bracelet just before Roberts left his residence the day of the shooting. Tyler Eheler told me Roberts wore the bracelet all the time and gave it to him. I photographed the pink bracelet that read "FUCK CANCER" and gave the bracelet back to Tyler Eheler. I later saved the photographs to a CD and made a copy of the CD for the case file. I later placed the first CD into CCSO evidence, and attached a photograph to this report.

This report is a brief summary of Tyler Eheler's statement. For further details listen to Tyler Eheler's audio recorded interview.


At about 1500 hours, I began the audio recorded interview. Tyler Eheler told me he last saw Roberts about 1500 hours the day of the shooting. Tyler Eheler told me Roberts arrived in his green Volkswagen Jetta, but did not call like he normally does. Roberts told Tyler Eheler that he no longer had a phone.

Tyler Eheler told me Roberts came into his residence, and he finished up the video games he was playing. Tyler Eheler told me Roberts explained to him that he was leaving town and going some place warm, but not Hawaii. Roberts told Tyler Eheler that things were going bad and to not tell Tyler's sister (Jaime) and Chris that he was leaving. Tyler Eheler told me he assumed there was some kind of fight between Roberts and his sister and Chris, and Roberts got kicked out.

Tyler Eheler told me Roberts was supposed to leave for Hawaii on Thursday (12-06-12) at 1500 hours. Tyler Eheler thought Roberts was going to Honolulu, and seemed to have things planned out. Roberts was supposed to be flying on Alaska Airlines. Roberts missed his flight and rescheduled his flight for Thursday (12-13-12), but was not sure of the time. Tyler Eheler told me Roberts was pretty punctual and would do something he paid for.

Tyler Eheler told me he and Roberts talked inside the residence, and spoke briefly the day of the incident. Tyler Eheler told me they went outside to smoke, and he thought Roberts did not really want to leave and was sad. Tyler Eheler told me Roberts talked about leaving, but Roberts was vague and evasive. Tyler Eheler told me he could not figure out why things were going bad for Roberts.

Tyler Eheler told me it was an odd good bye and Roberts seemed to stall because he really did not want to go. Tyler Eheler told me Roberts would take a few steps toward the door then stop and face Tyler and start talking again.



I asked Tyler Eheler if he remembered what words Roberts used to explain how things were "bad". Tyler Eheler told me he thought Roberts said, "Shit's gone down", "things have gone bad", and not to tell Jaime and Chris that he was there because he was leaving now and not to tell them until tomorrow. Tyler Eheler told me the conversation then shifted to the fact that they would not see each other again.

I asked Tyler Eheler why Roberts did not want him to tell Jaime and Chris about Roberts leaving until the next day. Tyler Eheler told me he assumed it was because there was assault rifle ammunition found in Roberts' room, and Roberts might have been concerned that they would have told police.

I asked Tyler Eheler if he was concerned that Roberts was going to hurt himself or someone else. Tyler Eheler told me Roberts was not a violent person. Tyler Eheler told me he did not put "two and two together" until his mother (Kelly) called him and told him there was a shooting at the mall. Tyler Eheler told me when he turned on the News he learned the shooter was wearing all black and he thought "Ah, crap, Jake was in all black."

Tyler Eheler told me Jaime called him and stated Roberts was dressed in all black and acting really funny when he left. Jaime told Tyler Eheler that she found assault rifle ammunition in Roberts' room.


I asked Tyler Eheler what Roberts was wearing when he arrived at his residence. Tyler Eheler told me Roberts was wearing a jean jacket, a hooded sweatshirt underneath the jacket or the jacket had a hood attached, and possibly jeans.

I asked Tyler Eheler if it was odd that Roberts had ammunition. Tyler Eheler told me Roberts goes shooting, and had taken him shooting before. Tyler Eheler told me it was normal for Roberts to buy ammunition and take people shooting. Tyler Eheler told me he thought Roberts had a .45 caliber handgun and possibly a 9mm handgun, but thought Roberts had sold both. Tyler Eheler told me Roberts always went shooting with at least one other person.

Tyler Eheler told me Roberts was training to be a Marine every Thursday night for 2 hours in the area of SE Mcloughlin Blvd/SE Roethe Rd in Milwaukie, and would have had an assault rifle in his hands before. Tyler Eheler told me he and Roberts were getting ready for the delayed entry training program for the Marines at 17 years old. Roberts was really excited about going into the Marine Corp.

Tyler Eheler told me the training to be Marines that he and Roberts received was mostly physical training and the history of the Marine Corp. Tyler Eheler told me there were not any firearms training, but there were team building exercises the group would do (such as paintball or rafting). Tyler Eheler told me Roberts did receive training on field stripping an assault rifle and was the second fastest in the class, second to the staff sergeant. Tyler Eheler told me he was not sure what rifle Roberts learned to field strip, but thought it was something at started with an "AR" or possibly an "M4A1".

Tyler Eheler told me he and Roberts did not really talk about assault rifles, but he thought Roberts did want to get a shotgun and take it shooting. Tyler Eheler told me Roberts' deployment date to Boot Camp was already set prior to getting hurt.



Tyler Eheler told me Roberts initially passed his physical for the Military, but Roberts ended up breaking his ankle at a skateboard park. Tyler Eheler told me Roberts ended up having "hardware" put in his ankle which disqualified him from the Military.

Tyler Eheler told me Roberts was pretty depressed when he hurt his ankle and had to stay off of his foot for a couple months. Tyler Eheler told me once Roberts was able to get around on his foot again, Roberts bounced back. Tyler Eheler told me Roberts smoked marijuana and ate mushrooms. Tyler Eheler told me he thought Roberts ate mushrooms seven times, but did not start eating mushrooms until after he hurt his ankle. Tyler Eheler told me Roberts' aunt would give Roberts mushrooms and sometimes Roberts and Roberts' aunt would eat the mushrooms together. Tyler Eheler told me the last time Roberts ate mushrooms was last Halloween.

Tyler Eheler told me Roberts smoked marijuana daily, and the last time he knows of Roberts smoking marijuana was the day of the shooting. Tyler Eheler told me Roberts smoked marijuana at his (Tyler's) residence. Tyler Eheler told me he did not have that much marijuana and Roberts really wanted some. Tyler Eheler told me Roberts was leaving and it was the last time he was going to see him, so Tyler gave Roberts the last small bit of his Marijuana.

I asked Tyler Eheler if he knew of any other controlled substances Roberts used. Tyler Eheler told me Roberts was using cocaine before Roberts moved in with Jaime. The last time Roberts used cocaine that he knew of was about 4 years ago. Tyler Eheler told me he had never known Roberts to use heroin or methamphetamine.

Tyler Eheler told me Roberts gave him a hug goodbye which was awkward. Tyler Eheler told me this was weird because the only other time Roberts had ever hugged him was when he and Roberts were reunited after they got separated running from an under age drinking party. Tyler Eheler told me the day of the shooting Roberts hugged him twice. Tyler Eheler told me he thought Roberts was just upset about moving away, as it looked like Roberts was going to cry. Tyler Eheler told me he was shocked that Roberts was leaving. Tyler Eheler told me Roberts might have been dropping hints about things, but he could not get over the fact that Roberts was leaving.

I asked Tyler Eheler if Roberts explained why he was not going to Hawaii. Tyler Eheler told me Roberts just told him that he was not going to Hawaii and was just going to drive somewhere today. Tyler Eheler told me Roberts stated he was not going to take a plane anywhere and he was just going to drive. Tyler Eheler told me this was kind of weird because up to this point Roberts had been trying to sell his car. Tyler Eheler told me that Roberts left and stated he would call him.

I asked Tyler Eheler if Roberts left after walking out to his car. Tyler Eheler told me Roberts was out in front of his house for a minute or two, and he considered running out to see Roberts again, but then Roberts drove off. Tyler Eheler told me he decided not to go outside. Tyler Eheler could not see into Roberts' car.

Tyler Eheler told me he and his family were in Las Vegas from 12-06-12 through 12-09-12. Tyler Eheler told me Roberts was supposed to leave for Hawaii on Saturday, 12-08-12. Tyler Eheler told me when he returned from Las Vegas he was surprised to find out that Roberts had not gone to Hawaii. Tyler Eheler told me he found out that Roberts had changed his Hawaii flight to 12-13-12.

Tyler Eheler told me he hung out with Roberts on 12-10-12 and they played video games together. Tyler Eheler told me he had planned to hangout with a friend named Phillip that night, so he invited Roberts to join them. Tyler Eheler told me Roberts did not want to because he was going to a strip club, which he invited Tyler to, but Tyler declined. Tyler Eheler told me Roberts was going to a strip club called "DV8" in Portland. Tyler Eheler told me Roberts was going to the strip club every night since he (Tyler) returned from Las Vegas, which seemed odd that Roberts was going to a strip club.

I advised Tyler Eheler that Roberts was going to the strip club for the last three nights; and I asked Tyler Eheler if he knew of Roberts going to strip clubs prior to that. Tyler Eheler told me he was not sure, but he assumed Roberts had been going for a little while.

Tyler Eheler told me Roberts' girlfriend was "Bonnie", but when Roberts told her he was moving to Hawaii in two weeks, Bonnie left him.

I asked Tyler Eheler why Roberts suddenly decided to move to Hawaii. Tyler Eheler told me Roberts' grandparents died and left him money that was invested. Tyler Eheler told me Roberts had received two large amounts of money, and the third and final check was going to be received in about a week. Tyler Eheler told me Roberts planned to use the money to go to Hawaii or cash the check in Hawaii, he (Tyler) was not sure. Tyler Eheler thought Roberts was going to be receiving a check for \$26,000.00.

Tyler Eheler told me Roberts cashed the two previous checks when he was 18 years old. Tyler Eheler remembered the two checks Roberts received as \$12,000.00 and \$16,000.00 which he and Roberts spent over the course of a summer. Tyler Eheler told me during that summer neither of them worked and they just rode their bikes wherever and Roberts would pay for everything. Tyler Eheler said, "We lived like kings."

I asked Tyler Eheler what he and Roberts did that summer. Tyler Eheler stated they smoked marijuana, drank a lot, ate at McDonalds everyday, rode their bikes all over, and if where they were going was too far to bike to Roberts would pay for bus fare.

I asked Tyler Eheler what jobs Roberts had. Tyler Eheler told me Roberts worked for Goodwill, he worked construction (for Katie Dunlap's father), he trained to be a "fire jumper", he worked at Big Bertha's, and during high school he worked at Carl's Junior.

I asked Tyler Eheler about Roberts training to be a smoke jumper. Tyler Eheler told me smoke jumpers parachute into forest fires. Tyler Eheler told me Roberts got his certifications through Clackamas Community College. Tyler Eheler told me Roberts could not get a job because he did not have experience. Tyler Eheler told me Roberts was an adrenaline junky. Roberts liked skateboarding, biking, skydiving, and girls. Roberts liked Big Bertha's because all the girls.

Tyler Eheler told me Roberts dated two girls named "Hanna", Bonnie, and maybe a "Nikki". Tyler Eheler did not know any of Roberts' girlfriend's last names.

Tyler Eheler told me he and Roberts were friends with Phillip Boyd, but Phillip and Roberts had a "falling out" about three years ago. I asked Tyler Eheler what the "falling out" was. Tyler Eheler explained that on Phillip's 20th birthday party Phillip got arrested and while Phillip

was in jail Roberts "got with" Phillip's fiancé that night and the next day. Tyler Eheler told me that incident occurred three years ago and is behind all of them now and Phillip, Roberts and Tyler were all drinking together a week ago.

Tyler Eheler told me he and Roberts had a "falling out" as well, but it was over the same incident. Tyler Eheler told me that he and Roberts "falling out" lasted about a year.

I asked Tyler Eheler when Roberts gave him the pink "FUCK CANCER" bracelet. Tyler Eheler told me Roberts gave him the bracelet as he was walking out the door on the day of the incident. Tyler Eheler told me Roberts gave him the bracelet, gave him a hug, told Tyler to take care, and said he would call him.

I asked Tyler Eheler if Roberts had given anything else to him. Tyler Eheler told me Roberts had not, but Roberts was selling everything. I asked Tyler Eheler if Roberts had a guitar case or knew about Roberts giving one away. Tyler Eheler told me Roberts did not have a guitar.

I asked Tyler Eheler who Roberts' close friends were. Tyler Eheler told me Cody McBride, Phillip Boyd, Tommy "Ilk" (Roberts' boss at Big Bertha's), Jacob "Ilk" (Tommy's brother) Jordan Macintosh, and Shawn (lives near 68th/Flavel).

I asked Tyler Eheler when he heard the suspect in the mall shooting was wearing black, why he thought it might have been Roberts. Tyler Eheler told me there were just some odd coincidences. Tyler Eheler told me Jaime found rifle ammunition in Roberts' room, Roberts left his Social Security Card in his room and he was supposed to be leaving town, Roberts had a white Jabawaki mask, Roberts was acting weird and wearing all black, and he and Roberts played "Call of Duty" all the time and could see Roberts running with a gun like the suspect did (as if the suspect was Military trained).

I asked Tyler Eheler what other games Roberts played. Tyler Eheler told me besides "Call of Duty" Roberts played "NFL 2008", "League of Legends", and he played pool a lot. Tyler Eheler told me Roberts was a "pool shark".

I asked Tyler Eheler if Roberts was involved in any social media. Tyler Eheler told me Roberts was the "epidemie of Facebook", and liked to write about what he was doing and have people comment on it. Tyler Eheler told me Roberts deleted his Myspace account a while ago, but did not know if he created another one. Tyler Eheler told me Roberts deleted his Myspace account because that was how his aunt Tammy was trying to contact him, and Roberts did not want anything to do with his aunt Tammy. Tyler Eheler told me Roberts might have used Twitter, but he was not sure.

Tyler Eheler was asked if he saw Roberts field strip the assault rifle or if he just heard about it. Tyler Eheler stated that he did not see Roberts field strip the assault rifle, but Roberts did brag about how fast he did it. Tyler Eheler told me Roberts was pretty close with several of the guys going through the Marine training.

The recording ends.

Tyler Eheler then stated that Roberts' Aunt Tammy was awful and did not treat Roberts well. Tyler Eheler told me Tammy would make Roberts massage her feet before she would let him

leave to go stay the night at his residence. Tyler Eheler told me Tammy apparently told the medical examiner's office that she was not going to pay for anything having to do with Roberts' funeral. Tyler Eheler told me Roberts' real mother died when he was 4 years old, and as far as he knows, three years is the longest Roberts has lived in any one place.

I asked Tyler Eheler if Roberts had any nicknames. Tyler Eheler told me he always called Roberts, "Jake" or sometimes the "Flyin' Hawaiian". Tyler Eheler told me Roberts had some nicknames for the games he played; such as, for Call of Duty Roberts' nickname was "Auschwitz Man", and for League of Legends Roberts' nickname was "Auschwitz".

I later saved Tyler Eheler's interview to a CD and made a copy of the CD for the case file. I placed the first CD into CCSO evidence.


On 12-14-12, at about 0934 hours, after an interview with Kelly Eheler at her residence, I spoke briefly with Tyler Eheler. I asked Tyler Eheler about the marijuana that he gave Roberts, and asked if he too had smoked marijuana out of the same bag. Tyler Eheler told me he had smoked marijuana out of the same bag prior to Roberts and it actually seemed a little weak. Tyler Eheler kind of laughed and told me the bag of marijuana actually went through the washing machine prior to him giving any to Roberts. Tyler Eheler told me he knew the marijuana was not laced with anything.

Detective Timeus showed Tyler Eheler a photograph of a male wearing a mask on a TriMet bus that stopped at the CTC. Tyler Eheler looked at the photograph and stated that he did not recognize the male in the mask, or the photograph of the same male prior to putting on the mask.

No further information.


SUSPECT: Roberts, Jacob Tyler

NARRATIVE:

On 12/11/12 at approximately 3:30pm I was on the fourth floor of the Sheriff's Office Headquarters and heard an unusually large number of sirens in the area. I logged on to the police dispatch program and saw that there was an 'active shooter' incident at the Clackamas Town Center mall, which is approximately six blocks from the office.

I got to my car and exited the parking lot and activated the emergency lights and siren in my unmarked police car. I drove west on Sunnybrook Blvd to 82nd Ave, took a right (north), and drove up 82nd Ave to the first mall entrance. I noticed that Detective Eggleston was parked at this location in his unmarked police car blocking traffic from entering. Just beyond him was what I recognized as an unmarked police Dodge charger belonging to our special investigations unit. I drove past Detective Eggleston's position and followed the SIU vehicle to the upper Macy's parking lot.

During the drive I was monitoring the radio traffic of the responding police and incoming information to dispatch. There was confusion as to if the suspect had been shooting while standing in the food court or someplace else in the mall. There were updates that the suspect was last seen entering "Macy's Home store", but other updates simply said he entered "Macy's". At this mall Macy's has a two level store on the west side devoted to only clothing and then another two level store on the east side of the mall that is only home furnishings. Since I was closest to the Macy's Clothing store I pulled up in front of the store and donned my ballistic vest and police identification. While in that location SIU Deputy Brummett arrived (driving the unmarked Dodge charger) and started getting his equipment ready. Milwaukie Detective Luke Straight arrived from somewhere and was already dressed in a ballistic vest,



helmet, and rifle. He covered the Macy's South doors. Sergeant Wold was the last to arrive at this location and he too had to take a minute and retrieve his equipment from his car.

During this time I saw uniformed Deputy Leikem standing in the parking lot near a planter island with a shotgun. When I looked at him he shouted to me that he was guarding a rifle mag that the suspect had dropped.

When Deputy Brummett and Sergeant Wold were ready the four of us moved up to the Macy's entry doors. Just before entering uniformed Deputy Lightner joined our group. Deputy Lighter tried to announce our entry on the radio but was unable to transmit due to other competing radio traffic. We decided to enter anyway. (note-looking back in the dispatch call there is an entry at 15:48 with Deputy Lightner, 2d80, advising a group is entering Macy's. It is unknown if that was the actual time we entered or after we were already inside.)

Inside Macy's we proceeded down the left side of the store. We watched for individuals hiding or injured as well as the possible suspect. Near the front of the store we encountered a white man in a suit and tie who identified himself as the store manager. At the same time entering the store from the mall were two other men who I didn't see but could hear Deputy Brummett and Detective Straight yelling at to stop and get on the ground. I contacted the man in the suit and looked at his ID from his wallet. I believed he was not involved so I told him to get out of the store using the doors behind us. He told me of another department manager who was hiding at a register so I told him to get him also and get out of the store.

My cell of officers left Macy's and went out into the mall. We were on the upper floor. In front of Macy's off to the right and up against the glass panel railing was a kiosk store. To the right of the kiosk was a deceased person. I could not tell if it was a man or woman because the body had been covered with a sheet or blanket. There was a large pool of blood on the tile floor in the area of the person's head. I noticed a large number of spent bullet shells on the floor in the area in front of Macy's.

We decided to head east towards JCPenny's in search of the suspect. We did not see or hear any traditional 'indicators' that would identify that the suspect was still actively shooting. Most all of the businesses we passed had their gates down. The few stores where we saw people inside we ensured that no one inside needed medical attention and told them to stay there for later evacuation. When my team reached JCPenny we went down the mall escalator to the lower floor and began to sweep the stores back towards the middle of the mall. During this time officer's came and went from my original cell. On the lower floor of the mall there were many other teams of officers and so the 'cell' groupings were not as defined any longer. Two or three officers would join up and go into a store to clear it and evacuate any citizens and then disband or merge with others for another duty.

After the announcement was made on the police radio about finding the suspect deceased, the focus of the officers in the mall shifted to checking for injured people and evaluating people out of the individual stores. I assisted with this effort until it was decided to have detectives leave the mall interior and respond to the command post in the parking lot. When I returned to the area of my car, Deputy Leikem was still guarding the found rifle magazine. I released him from that duty and seized the item (see separate report) before arriving at the command post.



NARRATIVE:

On the evening of December 11, 2012, CCSO Detective Lisa Shipley and I contacted the suspect, Jacob Robert's roommates (Christopher Dahrens & Jaime Eheler) who had called in a "tip" and requested police contact.

At about 2100 hours, Detective Shipley and I arrived at the suspect's residence located at 7 Portland, Oregon. There Detective Shipley and I contacted the suspect's roommates Christopher Dahrens and Jaime Eheler.

Detective Shipley and I advised them of the situation and then conducted separate interviews with them in the living room of the residence. Please see the interview transcription reports for further information and details. Once complete CCSO Detectives Jeff Juker and Patrick Bray agreed to stay at the residence until investigators returned with a signed search warrant.

Afterwards, Detective Shipley and I contacted case agent, CCSO Detective Mike Copenhaver and provided him with the necessary information for the purposes of writing a search warrant affidavit to be served at the suspect's residence.
